- Vendor agrees not to sublet space or exhibit merchandise other than specified on the registration form without permission from organizer. Booths may be shared by 2 vendors.
- · Organizer reserves the right to reject, restrict or remove a vendor.
- No vendors may sell or distribute offensive, dangerous, illegal, racist, homophobic, misogynistic, hateful, religious, political or other controversial material.
- · Vendors may not distribute alcohol.
- · Vendors must behave in a civilized manner.
- Vendor agrees that space assignments may be changed by the organizer.
- · Vendors are liable for any damage or defacement to event structures caused by their exhibit.
- ALL tents must be weighted down with sandbags or weights.
- ALL booths must comply with local fire, health, and safety regulations.
- Set-up time begins at 8am on Saturday, May 2, 2020. Breakdown at dusk.
- · Unless event is canceled there will be no refunds. All sales are final.
- Sponsors and vendors must supply their own tables, tents and chairs and will not have access to power. Generators ok. Booths may not exceed 10'x10'.
