

Giveaway & Registration Terms & Conditions

NO PURCHASE REQUIRED

Sponsor. Campus-Smiles.

By registering with the Campus-Smiles Dental Office, participants qualify for the following promotion: a \$500 credit (“Giveaway”) to the university’s campus bookstore. Winners of the Giveaway will be selected at random, drawing anonymously from among participants. No purchase of any kind is required to participate in the Giveaway.

Eligibility. The Giveaway is open to any and all individuals currently enrolled as a student (part-time or full-time) and/or to students who will be enrolled during the 2017 summer or fall semesters at a Campus-Smiles hosting university. Registration submission with the local Campus-Smiles Dental Office is required. No employees of the Campus-Smiles’ hosting university nor those employed by the Sponsor or its affiliates, including their immediate family members, are eligible to participate in this Giveaway.

How to Enter. All university Campus-Smiles’ offices have a designated Giveaway form. Please ensure that the university you attend or plan to attend is correctly designated at the top of your registration form. For the Giveaway registration, simply provide your first name, last name, email address, and cell phone number. Registrants must agree to the Terms & Conditions provided herein by checking the corresponding element. Follow any additional entry form instructions before submitting your registration. Successful entrants will be sent to a submission confirmation page and redirected back to the dental office’s website. If you are not sent to a confirmation page after submitting your registration form, please fill out the form again and resubmit.

Prize(s) and Winner Selection Method. The Sponsor will award a prize to one or more individuals who register for the Giveaway using the selection method described herein. The Giveaway form will specify the prize, approximate retail value, and the duration of the giveaway (which may be sooner than the end dates and times provided depending on the available supply of prizes). Winner selection will be conducted at random using a computer generated identification method. All submitting an eligible entry (accurate biographical and contact information) will have as equal a chance to win as any other qualified entrant. Odds of winning depend entirely on the number of entries received. Limit one registration per person.

Redeeming Prizes. Winners will be notified via email upon selection. If the Sponsor fails to receive a response via communication from the selected winner within 48 hours of the initial notification, the Sponsor will attempt to contact the winner via the cell phone information provided at registration. If the Sponsor is unable to contact the winner and/or does not receive a documented response from the winner within 72 hours of the attempted phone call, the Sponsor reserves the right to select a new winner using the same random-selection method described above.

Sponsor is offering a prize to one or more randomly drawn individuals who enter during the entry period. See the linked announcement for prize details and the number of winners. Prize(s) will be fulfilled by Sponsor, and if you are a winner, Sponsor will use employees from the hosting dental office to notify you that you have won and ask you to make a selection from the prize options available. The hosting dental office will also conduct delivery of the selected prize. Winners who respond within the five (5) day notification period, but who fail to collect their prize within three weeks (21 days) of initial notification may

forfeit their right to redeem their prize. After 21 days, the local Campus-Smiles dental office will have sole discretion over whether to deliver the prize at this point or to choose a new winner. Each prize will be awarded “as is” and without warranty, except for that provided by the manufacturer of the prize itself, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). Winners may not transfer, assign, or redeem the prize for cash. The Sponsor reserves the right to substitute a prize with one of equal or greater value.

Additional Terms. The Sponsor reserves the right to modify or cancel the Giveaway at any time. The Sponsor and its affiliates are not responsible for: (a) lost, misdirected, late, or incomplete entries or for inaccurate entry information; (b) any operation or transmission error, theft, unauthorized access to, or alteration of, entries; or (c) damage to any computer or device resulting from downloading Giveaway materials. The Sponsor may disqualify any individual found to be: (x) tampering with the Giveaway in any manner; (y) violating these Terms & Conditions; or (z) acting in a disruptive manner or with intent to threaten or harass any person. Incomplete and robotic, automatic, programmed or similar entries will be disqualified. The authorized at the time of entry will be deemed to be the participant and must comply with these Terms & Conditions in the event of a dispute as to entries submitted by multiple having the same e-mail account.

No greater than the number of prizes stated on the Giveaway Landing Page will be awarded. If any errors occur in the selection of a potential winner, Sponsor may award the prize(s) by random drawing from among all eligible registrants using a different random-selection manner than the one described herein. All prizes made available for a Giveaway may not be awarded in the event Sponsor does not receive a sufficient number of qualified and eligible entries for an applicable Giveaway.

Miscellaneous. Each Giveaway complies with the laws of the United States. By entering the Giveaway, you agree (for yourself and your heirs) that Sponsor, and each of their respective affiliates and agents, and any entity involved in any aspect of the Giveaway (all aforementioned parties are collectively, the “Released Parties”) will have no liability, and will be held harmless from and against liability, loss, injury or damage to property or person, including death, and reasonable attorney’s fees and court costs, due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use or misuse of a prize or participation in the Giveaway, even if caused or contributed to by the negligence of any of the Released Parties.

By entering the promotion you agree that Sponsor, and each of their respective affiliates, will have no liability, and will be held harmless from and against any liability or loss, including reasonable attorney’s fees and costs, for all matters related to your acceptance, possession, experience with, use or misuse of the prize or participation in the promotion.

You agree that Sponsor’s decisions related to each Giveaway and all distribution of prizes are final. Any and all information you disclose – contact information or otherwise – will be kept confidential and will not be shared with third parties.
