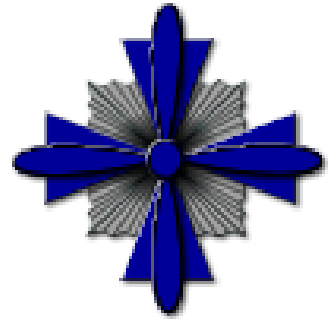

## Mini Trial Divisions Offered:

**JR/SR Baby Starter:** True beginners, dressage test may be read. Dressage Test: 2015 USDF Introductory Test B. Stadium: Maximum 18". Cross Country: Ground poles up to 18".

**JR/SR Starter:** Green horse/Rider. Dressage Test: 2015 USDF Introductory Test C. Stadium: Maximum 2'3". Cross Country: Maximum 2'3".

**JR/SR Beginner Novice:** 2014 Beginner Novice Test A. Stadium: Maximum 2'7". Cross Country: Maximum 2'7".

**Novice:** 2014 Novice Test A. Stadium: Maximum 2'11". Cross Country: Maximum 2'11".

## Combined Test Divisions Offered:

**Training:** 2014 Training Test A. Stadium: Maximum 3'3".

**Preliminary:** 2014 Preliminary Test A. Stadium: Maximum: 3'6".

## Dressage Test(s) Offered:

Any USDF Level tests or any USEF Level test.

**ALL DIVISIONS RUN OVER ONE DAY, ALL DIVISIONS WILL BE PINNED  
WITHIN 30 MINUTES OF END OF DIVISION.**

Awards: MT Ribbons awarded 1-10 CT and Dressage Ribbons awarded 1-6

**Mini Trial Entry Fee:** Both days - \$240 or \$220 for 42 FDL members. Must have 42 FDL number in order to receive discount.

One day - \$130 or \$120 to 42 FDL members. Must have 42 FDL number in order to receive discount.

**Combined Test Entry Fee:** Both days - \$90 One day- \$65

**Dressage Ride a Test Fee:** \$25 per test \$25

Late Fee assessed for entries received after close date. Same horse/rider combo can compete on BOTH days. One entry form for both days is sufficient, please mark both days.

Dressage is first, followed by show jumping. Cross Country available immediately after. ALL times will be given. Riders MUST jump the XC jumps assigned to their division to be eligible for prizes.

Everyone MUST have signed a release before getting on your horse! Medical Armbands or wristbands must be used in jumping phases, and vests must be worn in XC phase.

Schooling available, \$35/ horse, must be approved by Mary Lowry. Call or email for schooling.
