JR/SR Baby Starter: True beginners, dressage test may be read. Dressage Test: 2015 USDF Introductory Test B. Stadium: Maximum 18". Cross Country: Ground poles up to 18".

JR/SR Starter: Green horse/Rider. Dressage Test: 2018 Beginner Novice Test A. Stadium: Maximum 2'3". Cross Country: Maximum 2'3".

JR/SR Beginner Novice: 2018 Beginner Novice Test A. Stadium: Maximum 2'7". Cross Country: Maximum 2'7".

Dressage Test(s) Offered:

Any USDF Level test or any USEF Level test. Please note test of choice on entry form.

ALL DIVISIONS RUN OVER ONE DAY.

ALL DIVISIONS WILL BE PINNED WITHIN 30 MINUTES OF END OF DIVISION.

Divisions will run Smallest to Largest with Dressage Ride A Tests at the end of the day.

Awards: MT Ribbons awarded 1-10 CT and Dressage Ribbons awarded 1-6

Mini Trial Entry Fee: Both days - \$240 (\$220 for 42 FDL members)

One day - \$130 (\$120 for 42 FDL members).

Dressage Ride a Test Fee: \$25 per test

Refunds: Before C.D.-Less \$25 non-refundable office fee; After C.D.-No refund/stabling unless the spot is filled from wait list.

Late Entries: \$25 Late Fee assessed for entries received after close date.

Same horse/rider combo can compete on BOTH days. One entry form for both days is sufficient, please mark both days.

Stabling: On site stabling \$45/night. Please specify "stable with" when making reservations.

Everyone MUST have signed a release before getting on your horse! Medical Armbands or wristbands must be used in jumping phases, and vests must be worn in XC phase.
