FROM THE PRESIDENT

I am hoping you are keeping your brain stimulated while you keep your body warm during this



very cold winter. I promised you I would share my knowledge of some brain ailments so in this newsletter we will be learning about Stroke, Transient Ischemic attack (TIA) and Aneurysms.

A stroke happens when blood flow to a part of the brain is interrupted as a result of a rupture or blocked blood vessel. Brain cells that do not receive a constant supply of oxygenated blood may die, causing permanent damage to the brain. There are two types of strokes: Hemorrhagic and ischemic. A hemorrhagic stroke occurs when a blood vessel in the brain rupture or breaks, allowing blood

to leak into the brain. An ischemic stroke occurs when a blood vessel carrying blood to the brain is blocked or restricted by severely narrowed arteries or thickened mass of blood called a blood clot. Fat, cholesterol and other substances can collect on the walls of blood vessels. Over time, these substances harden and form structures called plaque. The build-up of fat deposits and plaque clog arteries, narrowing the passageway for blood. When a blood clot forms in a cerebral blood vessel that is already very narrow, it is called a thrombotic stoke. When a blood clot that has formed elsewhere in the body breaks away and travels to a blood vessel in the brain, the result is an embolic stoke, or cerebral embolism. An embolic stoke may also result from an air bubble or other foreign substance in the blood that moves into and blocks a cerebral blood vessel.

The Transient Ischemic Attack or what many call a TIA is often called a ministroke. The TIA attack may be a warning that you may be getting a stroke within a year. A TIA usually lasts only a few minutes and does not cause permanent damage because the vessel is only blocked for a short period of time. About 1 in 3 people who have a TIA will eventually have a stroke.

Symptoms of a stroke and TIA are: (get to the ER if you think you are having a stroke or TIA) Severe headaches with not known cause, numbness or weakness of the face, arm or leg typically on

one side of the body, confusion and trouble speaking (slurred or garbled speech or difficulty understanding others), trouble seeing in one or both eyes, dizziness, loss of balance or coordination.

Risk factors you cannot change: Family history, age (65), Sex (men have more), Prior TIA's, Sickle cell disease, Race (blacks have more)

Risk factors you can change: High blood pressure (keep it low), High cholesterol (keep it low), diabetes (keep it under control) excess weight (keep under control), don't smoke, exercise 30 minutes a day, eat well (do not eat too much fat and salt) do not drink lots of alcohol and don't do illicit drugs.

Stroke and ITA's are diagnosed by a CT of the head (computed tomography) or a MRI which uses a powerful magnetic field, radio frequency pulses and a computer to produce detailed pictures of the brain.

Now a brain Aneurysm is a serious silent problem. A brain (cerebral) aneurysm is a bulging or weak area in the wall of an artery that supplies blood to the brain. In most cases, a brain aneurysm causes no symptoms and goes unnoticed and may only be found during tests for other conditions. A person may inherit the tendency to form aneurysms, or they may develop because of hardening of the arteries and aging.

Risk factors of a Brain Aneurysm are: Family history, previous aneurysm, women are more likely to develop one, African Americans are more likely than whites, high blood pressure and smoking,

Symptoms of a ruptured brain aneurysm (seek emergency service right away your life depends on it). You do not need all of these symptoms! A sudden severe headache, neck pain, nausea and vomiting, sensitivity to light, fainting or loss of consciousness or seizures.

The Brain Aneurysm is diagnosed by a CT, CTA (uses dye), MRA (Magnetic resonance angiography, uses dye), Cerebral angiogram (X-ray using a catheter into the groin to the brain, uses dye)

If the aneurysm is 10 mm they just watch it and make sure you live a healthy life style. If it is large they do surgery by either endovascular embolization or surgical clipping. If the aneurysm has bled in many cases they lead to death or disability.

Keep your brain healthy this year as we would like to see you at your District Meeting or at the Convention that will be held at the McCalmy Plaza Hotel in Battle Creek. October 3-5. The rooms are \$119.00 based on single or double occupancy and subject to applicable state and local taxes in effect at the time of check-in. The maximum number of people per guest room is four. They require a credit card at the time of hotel registration and they do not accept personal checks. They do accept cashier's checks, certified checks, Visa, Master Card, Discover, American Express and cash. If you do not have a credit card you have time to get one. You may cancel reservation, without penalty 72 hours to arrival. One-night room and tax will be charged for early departures. Check in is after 3:00 and check out is noon. All reservations must be made by 9-15-2018 at 12:00 a.m. in order to secure group room rates. Parking is complimentary. All food will be supplied by the hotel and no food or beverage may be removed from the hotel. The committee is in the process of finding workshops and entertainment but if you suddenly have an idea please contact Arlona. If they do not use your idea this year they may use it some other time in the future.

County Presidents please do not forget to send in your FCE New County Officer Forms so we have your address to send you correspondence. Joyce is looking for your educational reports. If you are interested in being a District Director of West U.P., North Central or East Central please get your application in by February 15th. If you are interested in being the Secretary of the FCE Board you have until July 1st to turn in the application. You may being some more changes such as a change in the way the convention is being handled. March 1st your Character Counts entries are due to Judith Gereau.
