Among his many accomplishments, Mr. Walters established the Hamburg NY Land Development Corporation, which allowed the Town of Hamburg, under his oversight, to purchase, market and develop a 145-acre industrial park from ArcelorMittal. This made it the first pre-permitted, shovel-ready site in Upstate New York, allowing the successful recruitment of a \$50 million FedEx regional distribution facility. Mr. Walters also initiated and executed numerous capital projects, including a new senior center, library expansion and new and/or renovated park facilities.

Mr. Walters serves as **Partner and Chief Legal Officer** of **Colby Development, LLC**. In this capacity he:
