Terms & Agreements:

- Minimum of 15 members are required for tour to operate, unless stated otherwise.
- Passport must be valid 6 months post travel date.
- To reserve, each traveler must provide 1) Completed Tour Application form, 2) Photo page copy of valid passport & 3) Deposit of \$500 USD to secure membership in group. All documents are accepted via fax, email OR hard copies mailed to office address.
- KJ International Tours accept payments in cash, check, debit & credit cards. Charges made with debit or credit cards require 4% charge fee. Charge fee is waived for \$500 USD deposit payment. To pay online, **[CLICK HERE TO BE DIRECTED](#)**.
- Payments are provided with confirmation by email. All payments are made to: KJ INTERNATIONAL TOURS. Return checks are charged an additional \$35.
- Land Package cost is based on current currency conversion rates. Should there be any major changes that would affect the cost, we will advise and you will have the option to cancel with full refund or pay the difference.
- Airfare is guaranteed; however taxes, fees and fuel surcharges are subject to change until tickets are issued. If there is any rate increase, we will advise and you will have the option to cancel with full refund or pay the difference.
- Final payment is due minimum (8) eight weeks prior to departure date OR when group membership is confirmed. Flight & hotel confirmation provided after final payment is made.
- If you decide to cancel your reservation after your deposit is paid, \$500 USD is **non-refundable**.
