Contract services per person:

- You may add people at any time up to the event date, IF TIME ALLOWS FOR IT. You may subtract people up to 2 weeks before the event date. After that 50% of their services will be due and if you subtract within 48 hours 100% will be due.
- You may cancel this contract at any time up to 2 weeks before the event date and will only lose your deposit. After that, you will be charged 50% of the quoted rate. If you cancel within 48 hours prior to the event date, you will be charged 100% of the quoted rate. This contract is non-negotiable.
