Methanol fuel will be available for sale at the track in the USAC pit area. Each methanol-fueled car must be accompanied by (2) five gallon pails of water and all cars must have at least one fire extinguisher in their stall. All passes will be available, including the race procedure packet, at the track sign in station. All on track cars must be brought in by 6PM, Thursday, April 5<sup>th</sup>, 2018. Pit spaces will be assigned as cars arrive and all teams will work from their trailers. All on track cars will be inspected according to the attached inspection explanation.

On-track cars will be split into two separate groups. Group 'A' cars will have a top straightaway speed of 80mph, Group 'B' cars will have a top straightaway speed of 120mph and a minimum straightaway speed of 80mph measured 3/4's of the way down the frontstretch. Cars can run in both groups but must adhere to the speed and safety regulations. Speed will be checked by RADAR.
