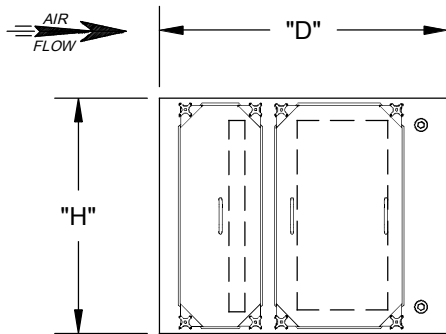
AIR FLOW DIRECTION

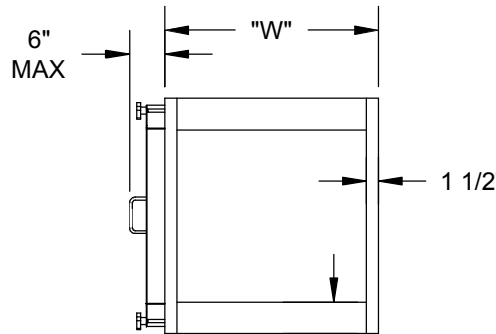
