- o Will TRS be two semesters? Two PHL, new ideas generated
- Senator Volz: Will this affect incoming freshmen or sophomores as well?
- This will affect incoming freshmen, but will be determined. Tracking sheets will be go into effect Fall 2018, it will be available, but won't be mapped to current requirements. New curriculum not existing curriculum.
- o Requirements
- Senator O'Grady: Does this have effect on honors tracks?
- Honors Program will follow discussion but is working to develop a plan.
   Instinct is that Honors classes already address "Enduring Questions," so this is TBD.
- Senator Giangiordano: If you substitute a class will I have to make up that class later?
- No, substitutions are permanent, but will need to fit certain requirements.
  For example, physics won't fit into Literature as a substitute, but Calculus
  would fit into a Math class. Complicated for switching majors, but it will
  work.
- Senator Kilgore: If you're on Honors track, and it changes to new curriculum, do you stay on Honors track?

- Yes, new requirements will not affect group of existing students, so you would stay on the same track you initially entered into.
- Academically speaking, we think of curriculum as contract, so when we change requirements, they are changed for class following you, so we aren't breaking contract.
- Senator Mackissey: Does Dr. Abela and committee believe it will be ready for the incoming class?
- Yes. There is a lot of work to do, but it will be done. We are fairly convinced we can do what we need for Fall 2018. Don't think every single class will be ready, but in terms of suggesting correct courses for freshmen, we believe we can.
- Senator Mackissey: Is this something we are advertising to incoming Freshmen?
- Yes, at previous open house, Dr. Abela did start to discuss, we are working with Admissions and Marketing to publicize and organize. Press release is our first step in the right direction.
- Excited to develop a new curriculum aligned with mission of University and in response to feedback we have
- Senator Skros: Will advising staff be retrained to properly advise students?
- Yes, we are in a good position of making staff aware as they advise over the summer. New advising platform
- o Senator Kilgore: Can you tell us about new focuses?
- I will be more than happy to come back in spring as we have further development
- Senator Calotta: As a nursing major, it is hard to fit in all classes. Can you tell us more about substitutions?
- Some curriculums on campus are more rigorous/complicated than others.
   We need to sit down and look at these more carefully, and look at what classes will be substituted.
- Senator Mackissey: My undergrad advisor and major advisor were not on the same page. Is there any way we could have one advisor all the way through, or increased training for advisors?
- Yes, we tried to do that this year in UAC to enforce advisors to give proper advice. We took each advisor and gave each advisor a specialty, and will work to increase New system will track minor completion much better and closely
