1. All invoices are to be paid at time of order. Unless other terms have been given in writing by Cass County Choppers, LLC.
2. Dealer agrees to comply with all retail pricing as provided by Cass County Choppers, LLC.
3. All photos and marketing materials are copy written and written permission is required to reproduce, reprint or use on dealer's website.
4. Cass County Choppers, LLC. will list your dealership in our social media content when being placed.
5. Dealer assumes all installation liability and/or adverse actions when installing our Trike Kit or Components.
6. Dealer must give the provided owners documents envelope to the customer at time of purchase from above mentioned authorized dealer.
7. The authorized dealer shall and must engage in marketing efforts to maximize sales and performance of Cass County Choppers, LLC. products.
8. New Dealers will be charged retail with a discount of \$375.00 on first complete trike kit purchased excluding shipping and handling and any regulated state, county and city taxes. Dealer will be eligible for dealer pricing upon ordering second complete trike kit and thereafter with agreed terms between said dealer and Cass County Choppers, LLC.
9. The dealer is not the agent, employee or legal representative of Cass County Choppers, LLC. for any purpose whatsoever, but is an independent authorized dealer. The authorized dealer is not granted any right or authority to assume or create any obligation, express or implied, on behalf of or in the name of Cass County Choppers, LLC. or bind Cass County Trikes, LLC. in any manner or thing whatsoever.
10. Cass County Choppers, LLC. will not drop ship any product unless previously agreed.
11. Authorized Dealer must have retail store and shop where installation and service of trikes can be performed. Said mentioned dealer must and shall have all state and federally regulated licenses, permits, insurances and etc. required by law and/or laws in mentioned dealers state.
12. Cass County Choppers, LLC. reserves the right to cancel dealer agreement at any time, if; - the dealer breaches any part of this agreement - the dealer makes any unauthorized use of property and proprietary information, price list or trade secrets. - ownership or control of the dealer is substantially changed.
13. All returns are subject to restocking fees, shipping and handling, and credit card fees when applicable. Returned items must be in original packaging and in original condition. All items returned must be accompanied by copy of invoice. Returns are subject to inspection upon receipt. Any dispute, controversy or claim arising out of or relating in any way to [the agreement/the relationship] including without limitation any dispute concerning the construction, validity, interpretation, enforceability or breach [of the agreement], shall be exclusively resolved by binding arbitration upon a Party's submission of the dispute to arbitration.
