The Liberty Woman's Club

An Evolving Club

About three years ago the members of Liberty Woman's Club voted to redesign their clubs' format and it has been evolving ever since. The first big change implemented was going from meeting in homes to meeting in restaurants and meeting for lunch instead of during dinner time. This took a great deal of pressure off of monthly hostesses. While the idea was sound, the club encountered a problem very early on. In the small town there is almost no restaurants with private spaces and the noise level was not conducive to holding a meeting.

The club changed directions again. Monthly meetings were moved to a church assembly room. This worked exceptionally well in that there was a kitchen directly adjacent to the meeting area. During the planning phase of this change, the club also decided, since they were no longer meeting in restaurants, to provide lunch for members attending meetings. A \$5 charge for each regular meeting was collected at the same time dues and scholarships contributions were made to provide lunch. Members RSVP if they can't make a meeting so the social secretary, the member in charge of securing the meal, would have a count.

Moving to this format allowed this group to focus more on their projects rather than planning meeting programs. It also increased their impact on the community. Today instead of hearing a program on conservation, the club organizes litter pickups, get their hands dirty at a local ECO Farm planting trees with the Master Gardeners and Master Naturalists. They use their club scholarship to send local students to Panther Navigation, a summer program for middle school age children and do much more. Now, instead of spending a great deal of time in meetings discussing the things that they want to do for their community, the club members are active project initiators and participants.

In addition to the projects mentioned above, the Liberty Woman's club members are involved in teaching music, acting, directing and supporting the local theater group, supporting the local schools, collecting and filling totes and purses with personal items for the Family Time Crisis Center for victims of domestic abuse, advocating for Bridgehaven Children's Advocacy, CASA, and other projects in areas of Conservation, Education, Art. We like it, A LOT!

MLK Jr. Project – San Gabriel Woman's Club

Four members of the San Gabriel Woman's Club volunteered to help with the Martin Luther King Jr. Day Project in Georgetown. Approximately 80 teens came to participate in several projects to benefit the community. This was their day off from classes; yet they came to help. All of the organizations that participated are after school places for students to get help and stay out of trouble.

The Georgetown Project is a community-based nonprofit organization that builds and sustains a healthier culture and capacity for all children, youth and families in the Georgetown area. Their craft was making giant felt parts for Mr. Potato Head to be used with young children to create nurturing early environments important to the social, emotional and cognitive development. Another craft was making Valentine cards to be distributed to the elderly in their Meals on Wheels package. The NEST is associated with The Georgetown Project.

The NEST is associated with The Georgetown Project. NEST stands for Nurturing, Empowering, Supporting for Tomorrow and is a safe haven after the bell rings that offers basic needs, counseling, academic and enrichment support for high school students who are homeless, at-risk or living in transition. The teens made "welcome bags" for new students who come to The NEST. The bags were decorated with kind words and stuffed with hand-made stress balls, welcome notes, and personal care items.

Upward Bound program was the third project and is designed for high school students who have the potential to succeed in college and could benefit from: tutoring, academic enrichment, precollege skills development, career counseling, college visits, cultural enrichments and year-round academic and social support. UB provides opportunities for its scholars to succeed in high school and ultimately in college. Their craft was "Snowman Soup" – a cup with hot cocoa mix, marshmallows and a candy cane. These will be donated to The Williamson County Child Advocacy Center.

The fourth project we helped with was the Georgetown Y. The craft was weaving bracelets which will go the "Gold Star Kids" – those children who have lost a military parent.

The students then broke into several groups. Each table was given a jumbled quote by Martin Luther King, Jr. They had to put the quote together, decide what it meant, then give an example of how they could apply the saying to their lives. Very insightful answers were the result. The members of the San Gabriel ckub who helped with this project came away with hope for future generations.





The Comanche Heritage Club Article shared by Newspaper January 15th, 2019

The Comanche Heritage Club met on Tuesday, January 15th, 2019 in First Baptist Church Fellowship Hall. Hostesses Beth Fairbrother, Ruth Adele Waggoner, and Missy Jones had decorated for the meeting in 'picnic style' with a long table and red/white checked cloth and refreshments of the same vintage to set the stage for the speaker.

Beth Fairbrother introduced the guest speaker, Janice Williams. Janice is from Austin and is the Historian for the Captain James & Susannah Cunningham reunion held annually n Comanche at the Cunningham Reunion Grounds every August. The reunion is currently in its 130th year. The first reunion was held in 1889.

Janice told about her love for genealogy and the keeping of genealogy records. She initially became interested as a teenager pouring over family archives. At that time, her family lived in the Texas Panhandle and did not get to come to the reunion every year. Janice was particularly interested in the family tree structure given that James and Susannah had twelve children and 101 grandchildren. The early documents were prepared by Alma Meadows Cox in 1929. There were all prepared by hand, certificates of birth, marriage and death had to be obtained by writing letters and searching documents in archives. Many of the early courthouses in this area of Texas were destroyed by fire (common in those days); therefore, it was a time consuming process.

In 1889, the reunion held its 100th anniversary under the oak trees at the grounds. Approximately, 450 to 400 people attended and at that time, an updated genealogy record book was prepared by F. Lee and Bill Lawrence of Tyler, Texas. That book was presented to family members and included many of the stories about Captain James and Susannah. This book was prepared with the aid of computers, but was privately published for the event and a digital copy was not available.

In 1914, the reunion held its 125th anniversary. For that event Janice undertook the updating of the genealogy (by this time a very huge task as there are over 2000 descendants to keep track of). She was thankful for digital records, the ability to search on line, and self-publishing companies of the Internet. She did not use an official genealogy program but used many advanced features of Word such as outlining formats to distinguish generations, embedded pictures and stories, and indexing. It was a huge task.

The mayor of Bowie, Gaylynn Burris, was in attendance and read a proclamation congratulating the club on their many accomplishments in Bowie. It was a very special occasion!

Saturday morning will offer a unique opportunity to form a new club: a Legacy Club. If your family has a history of Federation membership, please join us to see how we can make a difference.


So sit back and fasten your seat belt; we're in for a rollicking good time. We look forward to seeing you in Austin where we will see "The Heart of a Volunteer in Action."

What to Know Before You Go

HOTEL:

Location: Crowne Plaza Austin, 6121 North IH-35, Austin, 78752

Reservations: Deadline: April 3, 2019

Attendees are responsible for making their own hotel reservations. To receive the TFWC rate of \$119 (single)/double), mention the Texas Federation of Women's Clubs. The rate includes daily complimentary full breakfast buffet. CREDENTIALS AND VOTING: Deadline to submit credentials form is April 5, 2019.

All GFWC Texas members are invited to attend the 122nd Annual Convention. However, like most Convention bodies, only certain members are designated as delegates, as specified in the bylaws, Article VII. Voting delegates attend Convention as voting delegates. Although entitled to vote in several capacities, a voting member shall have but one vote. Members who do not receive a vote attend as a non-voting member and may take part in discussion, but not make a motion

All eligible voting members shall be certified by the Credentials Chairman. Credentials cards will be issued at the Registration desk. The form to be submitted to obtain credentials is included in this Call to Convention.

Club level:

One delegate for each fifteen (15) members or major portions thereof, elected from per capita club membership whose names are on the roster of GFWC Texas as least two months prior to the Convention. This does not include the club president as she is a member of the Board of Directors and is eligible to vote by virtue of that position.

One delegate from each accredited Juniorette Club.

One accredited delegate from each ten (10) clubs, or major portion thereof in a City/County Federation

<u>Board Level:</u> All members of the GFWC Texas Board of Directors are eligible to vote. Members of the Board are:

Elected and appointed members:

State elected and appointed officers; District elected and appointed officers; Trustees;

Scholarship Representatives; Past State Presidents; State Life Members and Honorary members; and Club Presidents

Other Appointed members:

Chairmen of State Community Service Programs, Department s and Special Projects; Chairmen and members of the following state Standing Committees: Legislation, Bylaws, Resolutions, Finance, Projects and Contests Committee chairmen, Convention chairmen, and Life Membership Committee.

Working with domestic violence prevention, Honor Flight Alabama, and GFWC local keeps her closely connected to grassroots service.

Amendment 1: Establishing Cyber Clubs.

Amend ARTICLE III-MEMBERSHIP, Section 1-Classification by inserting a new paragraph B: <u>TFWC Cyber Club</u>: <u>The TFWC Cyber Club</u>: <u>The TFW</u>

Current Wording:

SECTION I - Classification

Membership in TFWC shall consist of Women's Clubs whose work and purpose are germane to the objects of TFWC. Membership shall be classified as follows:

A. General Clubs: Those clubs whose members pay per capita dues to TFWC and GFWC.

B. Junior Clubs: Those clubs whose membership is composed of young women. Such clubs shall hold active membership and shall participate in the Regular program of TFWC.

Proposed Amendment

SECTION I - Classification

Membership in TFWC shall consist of Women's Clubs whose work and purpose are germane to the objects of TFWC. Membership shall be classified as follows:

A. General Clubs: Those clubs whose members pay per capita dues to TFWC and GFWC.

B. <u>TFWC Cyber Club</u>: The TFWC Cyber Club shall be a General Club whose members pay per capita dues to TFWC and GFWC and whose purpose is germane to the objectives of TFWC but whose interaction is primarily done electronically.

[If adopted, Junior Clubs becomes paragraph C and subsequent paragraphs are relettered.]

If Adopted Will Read

SECTION I - Classification

Membership in TFWC shall consist of Women's Clubs whose work and purpose are germane to the objects of TFWC. Membership shall be classified as follows:

A. General Clubs: Those clubs whose members pay per capita dues to TFWC and GFWC.

B. TFWC Cyber Club: The TFWC Cyber Club shall be a General Club whose members pay per capita dues to TFWC and GFWC and whose purpose is germane to the objectives of TFWC but whose interaction is primarily done electronically.

Rationale: To provide a definition of the TFWC Cyber Club along with the other defined TFWC Classifications.

<u>Conforming Amendment 1A: Insert a new Article XIV, defining procedures for a Cyber Club.</u> If amendment 1 is not adopted, this amendment will not be considered. If amendment 1 and this conforming amendment are adopted, subsequent Articles will be renumbered.

Current Wording

Article XIV—Junior Clubs

SECTION I: A club/department whose membership is composed of young women may be classified as a junior club.

SECTION 2: Junior clubs shall hold active membership in TFWC and shall participate in regular programs of TFWC and GFWC.

Proposed Amendment

Article XIV - GFWC Texas Cyber Club

SECTION 1 – Membership

A. The TFWC Cyber Club shall be a General Club whose members pay per capita dues to TFWC and GFWC and whose purpose is germane to the objectives of TFWC but whose interaction will primarily be done electronically.

B. Texas Federation of Women's Clubs Cyber Club shall have its own set of bylaws that is compatible with those of the Texas Federation of Women's Clubs.

<u>C. The TFWC Cyber Club shall follow TFWC Bylaws Article III, Section 2 – Application to obtain membership in TFWC and GFWC.</u>

E. Members shall be affiliated with Capitol District and shall appear as a club in the TFWC Directory under Capitol District's club listings. TFWC Cyber Club members may attend District, TFWC, and GFWC meetings.

F. Members shall be eligible to serve on the district and TFWC Boards of Directors and shall meet all requirements laid out by TFWC to run for a district or state elective office.

SECTION 2 - Officers

A. A cyber club shall have as a minimum the following officers: President, Secretary, and Treasurer.

B. Officers shall be elected in even numbered years electronically or at the regular meeting during the TFWC convention and shall serve a two-year term of office to coordinate with the term of offices in TFWC and GFWC.

SECTION 3 – Meetings

A. Frequency of meetings of the club shall be set by the cyber club members.

B. Regular business meetings may be held electronically as well as during the TFWC fall board meeting or during the TFWC spring convention.

C. Like all GFWC Texas General Clubs, the TFWC Cyber Club shall be allotted one delegate for each fifteen (15) members, or major portion thereof, for TFWC fall boards and TFWC conventions. All other members may attend as non-voting members.

SECTION 4 – Programs and Projects

A. The programs and projects of the TFWC Cyber Club shall conform to those outlined by GFWC and TFWC.

B. The activities of the TFWC Cyber Club will be of interest to General Club members and thus should be shared with the editor of THE TEXAS CLUBWOMAN for publication.

C. The TFWC Cyber Club may participate in GFWC and TFWC reporting categories and shall send said reports to Capitol District chairmen.

SECTION 5 - Disposition of Club Assets

In the event the Cyber Club is dissolved, any remaining assets shall be turned over to the GFWC Texas Federation of Women's Clubs.

[If adopted, Junior Clubs shall become Article XV and subsequent Articles shall be renumbered.]

If Adopted Will Read

Article XIV- GFWC Texas Cyber Club

SECTION 1 – Membership

A. The TFWC Cyber Club shall be a General Club whose members pay per capita dues to TFWC and GFWC and whose purpose is germane to the objectives of TFWC but whose interaction will primarily be done electronically.

B. Texas Federation of Women's Clubs Cyber Club shall have its own set of bylaws that is compatible with those of the Texas Federation of Women's Clubs.

- C. The TFWC Cyber Club shall follow TFWC Bylaws Article III, Section 2 Application to obtain membership in TFWC and GFWC.
- E. Members shall be affiliated with Capitol District and shall appear as a club in the TFWC Directory under Capitol District's club listings. TFWC Cyber Club members may attend District, TFWC, and GFWC meetings.
- F. Members shall be eligible to serve on the district and TFWC Boards of Directors and shall meet all requirements laid out by TFWC to run for a district or state elective office.

Amendment 2: ARTICLE IX – EXECUTIVE COMMITTEE, SECTION 1 - Membership

Add at the end of the paragraph: No TFWC Past President shall be eligible to serve on the executive committee in any capacity.

Current Wording

ARTICLE IX - EXECUTIVE COMMITTEE

SECTION 1 - Membership

The Executive Committee shall be composed of the TFWC elected officers, the Secretary, the Finance Chairman, the Chairman of Trustees, the Chairman of the TFWC Scholarship Committee and the TFWC Director of Junior Clubs. The Parliamentarian shall meet with the committee upon the request of the President as a non-voting member.

Proposed Amendment

ARTICLE IX - EXECUTIVE COMMITTEE

SECTION 1 - Membership

The Executive Committee shall be composed of the TFWC elected officers, the Secretary, the Finance Chairman, the Chairman of Trustees, the Chairman of the TFWC Scholarship Committee and the TFWC Director of Junior Clubs. The Parliamentarian shall meet with the committee upon the request of the President as a non-voting member. No TFWC Past President shall be eligible to serve on the executive committee in any capacity.

If Adopted Will Read

ARTICLE IX – EXECUTIVE COMMITTEE

SECTION 1 - Membership

The Executive Committee shall be composed of the TFWC elected officers, the Secretary, the Finance Chairman, the Chairman of Trustees, the Chairman of the TFWC Scholarship Committee and the TFWC Director of Junior Clubs. The Parliamentarian shall meet with the committee upon the request of the President as a non-voting member. No TFWC Past President shall be eligible to serve on the executive committee in any capacity.

Rationale: Clarifiers the current policy. The bylaws currently state that no TFWC Past President serving as a District Trustee (Article XII, Section 3, B4) or Scholarship Representative (Article XIII, Section 3, B4) shall be eligible to serve as Chairman of those entities. Therefore, they were not eligible to serve on the Executive Committee. When the remaining officers were elected, a TFWC Past President was not eligible to be elected to one of those positions. This amendment clarifies the policy since the Secretary became an appointed position and the Finance Chairman (an appointed position) was included as a member of the Executive Committee.

Amendment 3: Redesignating Articles XII and XIII to conform to language in the TFWC HF Trust Document:

Amend Articles XII TFWC Historical Foundation and Article XIII TFWC Scholarship Committee by designating Article XII as TFWC Scholarship Committee and Article XIII as TFWC Historical Foundation. Content remains the same.

Rationale: To comply with the TFWC Historical Foundation Trust that stipulates that the TFWC Bylaws Article XIII will establish the procedures for the HF Trustees.
