

Fairhope Canine Camp Liability Waiver

I _____, hereby certify that my dog(s) is/are in good health and have not been ill with any communicable condition in the last 30 days. I also certify I have read and understand/agree to the following:

____ 1.*I understand that I am responsible for any harm or damage caused by my dog while my dog is in doggie day camp or boarding with Fairhope Canine Camp. I shall indemnify and hold harmless Fairhope Canine Camp (or, Ronald Gawrysh) for any claims made against the corporation for losses or damages of any kind suffered by Fairhope Canine Camp as a result of my failure to inform Fairhope Canine Camp of any pre-existing condition of the dog (such as illness or aggression problems.) I understand and agree in admitting my dog to Fairhope Canine Camp, the facility has relied on my representation that my dog is in good health and has not harmed or shown aggressive or threatening behavior towards any person or any other dog.

____ 2.*I understand and agree that Fairhope Canine Camp will not be liable for problems, damage, or injury caused by my dog provided reasonable care and precautions are followed by the staff. I understand that Fairhope Canine Camp is fully insured. I release Fairhope Canine Camp of any liability arising from my dog's attendance and participation in doggie day camp or boarding. I understand day camp and boarding are places where animals may co-mingle in groups. I understand my animal may be placed in a crate for "time outs" (not to exceed twenty minutes) or if injured in day camp. I understand when dogs play in groups, nicks and scratches may occur. If an injury occurs and is not deemed serious by the staff, day camp staff may or may not notify me immediately. If the injury is deemed not serious by staff, staff may determine it is okay for the dog to stay until the end of the day and then will inform me about it when I pick up my dog. If the injury is deemed serious by staff, I will be notified immediately.

____ 3.*I understand and agree that any problem or injury that develops with my dog will be treated as deemed best by Fairhope Canine Camp at their sole discretion, and that I assume full financial responsibility for any and all expenses involved

____ 4.*I understand that if my dog is left at Fairhope Canine Camp for a period of three days without contact from the owner, this dog will be considered abandoned and necessary steps will be taken to turn the animal over to the proper authorities.

____ 5.*I recognize that there are inherent risks of illness or injury when dealing with animals. Such risks include, but are not limited to, problems resulting from rough play and kennel cough (doggie colds).

____6.*I, as the owner, agree to be solely responsible for any and all acts or behavior of my pet while in the care of Fairhope Canine Camp. If my pet should become ill or seem to be in need of medical consideration, Fairhope Canine Camp reserves the right to administer basic first aid and/or to use any available veterinarian. I, the owner, shall pay any expenses so incurred.

____7. *I certify that I have read and understand the policies of the center as set forth on the proceeding pages and that I have read and understand the conditions and statements of this agreement.
