ORDINANCE NO. 2013- 31-A

AN ORDINANCE AMENDING THE CAMBRIA TOWNSHIP MANDATORY SEWER TAP-IN ORDINANCE / ORDINANCE NO. 31, TO INCLUDE AND MAKE APPLICABLE TO THE EBENSBURG BOROUGH MUNICIPAL AUTHORITY ALL OF ITS PROVISIONS AND AMENDING ORDINANCE NO. 31 AS TO ITS PENALTY PROVISIONS FOR VIOLATIONS.

WHEREAS the Municipal Authority of the Borough of Ebensburg does provide public sanitary sewer service in areas of the Township of Cambria; and

WHEREAS the Township of Cambria has a mandatory sanitary sewer tap-in Ordinance No. 31 including only Cambria Township and Cambria Township Sewer Authority requiring Sewer Tap-in(s) to the sewer system in the Township; and

WHEREAS the Board of Supervisors of the Township of Cambria and its desirous of amending such Ordinance so to include and make applicable to the Municipal Authority of the Borough of Ebensburg and all of the provisions of the said Cambria Township Ordinance No. 31.

NOW therefore, being it ordained and enacted by the Board of Supervisors of the Township of Cambria, and it is hereby ordained and enacted by authority of same as follows:


SECTION 1: In all of the sections of the Ordinance, i.e. Sections 1-13, same shall be deemed to be applicable to the Ebensburg Municipal Authority, in addition to the Township of Cambria and the Cambria Township Sewer Authority.

SECTION 2: In particular Section 11 shall be amended to read in addition to any penalty hereinabove prescribed, any person , firm or corporation failing to make a proper connection within the time specified, after due notice, shall upon connection thereof before any District Magistrate or other issuing authority, pay a fine or penalty of not more than Three


Hundred Dollars (\$300.00) for each and every offense, and costs, and in default of payment of said fine and costs, to be imprisoned in the Cambria County Jail for a period not exceeding thirty (30) days until such fine and costs are paid. Whenever such person, firm or corporation shall have been notified in writing by the Township or the appropriate applicable Authority that they are in violation of the "Amending" Ordinance, each day that such violation shall continue shall constitute a separate offence punishable by a like fine hereunder upon conviction thereof; and if convicted of violation any of the other provisions of this Ordinance shall pay a fine or penalty of not less than One Hundred Dollars (\$100.00) nor more than Six Hundred Dollars (\$600.00) plus costs and in default thereof, be sentenced to undergo imprisonment in the Cambria County Jail for not less than five (5) days nor more than thirty (30) days.

ORDAINED and ENACTED on this 8 day of July, 2013 by the Board of Supervisors of Cambria Township.




