5. You will be provided with statistics on your video on *Network Pages* and *Facebook* (if selected) on a monthly basis.
6. At the end of the selected contract period, you will be contacted to enquire on whether you want to extend the contract. If you choose not to extend the contract, the video will be removed from *Network Pages*. The video will not be used for any other purposes than to adhere to the contract selected.
7. We make no guarantees on the amount of traffic you will receive to your video on *Network Pages* or *Facebook* (if selected).
