Bob Paudert



Robert “Bob” Paudert began his law enforcement career in Tennessee with the Shelby County Sheriff’s Department in February of 1966. In August 1973 he volunteered for an assignment in Metro Aviation, a newly created unit and became a certified flight instructor within the first year. He was appointed as assistant commander of the Aviation Unit. He was promoted to Captain and again transferred back to Metro Narcotics as a shift commander. In 1988 he was appointed to Assistant Chief and assumed command of the Shelby County Narcotics Division where he remained until his retirement in 1990.

In March 1991 he was appointed as Chief of Police with the Bartlett Police Department in Tennessee and then in 1995 accepted a position as Chief of Police with the Rogersville, Missouri Police Department where he remained until retiring a second time in 1998. In 1998 Paudert joined the Mid-States Organized Crime Information Center in Springfield, Missouri and then in March of 1999 he accepted the position of West Memphis Police Department until August 2011 when he retired for a third time. August 2011 Chief Paudert was asked to join the SLATT team (State Local Anti Terrorism Training) and educate officers on the sovereign citizen movement. He discusses in detail the fatal shooting in West Memphis, AR May 2010, where two officers Brandon Paudert and Bill Evans were shot and killed by sovereign citizens.

Lieutenant Susan McCartney

Susan McCartney is currently a Lieutenant with the Jefferson Parish Sheriff's Office Narcotics Division and supervises the undercover group. She has 29 years of law enforcement experience. She was assigned to the patrol division, Project STAR and the Street Crimes Unit. She currently teaches Drug Law at the Jefferson Parish Sheriff's Office Training Academy and lectures about narcotics related topics to the Citizen's Academy and numerous other private organizations.

Detective Donald “Don” Bourg

Don began his tenure with the Terrebonne Parish Sheriff’s Office in 2003. He worked as a Correctional Officer in the Ashland State Penitentiary for about two (2) years before he was accepted into the Academy and became a Road Deputy. In 2009, after working on the road for (4) years, Don was an On-Duty victim of an Officer Involved Shooting. Don continued to serve the Sheriff’s Office as a Crime Lab Investigator for three (3) more years and as a Detective for the past five (5) years.

Mary Bourg, wife of Don Bourg

Mary began as a Dispatcher for the Terrebonne Parish Sheriff’s Office in 2001 and later moved to become a Telecommunicator with the Terrebonne Parish 911 District where she remained for the past eight years.
