Chairman's Closing Comments

On August 15th I had the privilege of attending the Racine County GOP Pints and Politics held at the Reef Point Brew Haus at the Racine Harbor. Very well done Lisa Bell Racine County GOP Chair!

During the event the Racine County Executive Mr. Jonathan Delagrave and Mount Pleasant Village President David DeGroot presented information on Foxconn and answered questions.

I am in awe as to how big this Foxconn thing is going to be for Wisconsin.

The very first thing I need to clear up is there are absolutely no corporate give a ways by the state.

Foxconn MUST reach and complete a series of set milestones. As each milestone is met then and only then does Foxconn receive a tax incentive. NOT a single penny is coming out of taxpayers' pockets or the state's budget and going into Foxconn's coffers - it's all incremental tax incentives.

Projections are that Foxconn will bring in over \$13 BILLION into the state's economy and hire over 13,000 employees. It is projected those jobs with benefits will average \$27 - \$28 an hour starting wages.

By 2020 it is anticipated the Foxconn facility will be about 3-5 million square feet and by 2024, 18-22 million square feet.

70% of the Foxconn employees must come from Wisconsin of which 45% must be from Racine County. Foxconn, Racine Unified School District, and Gateway Technical College are closely coordinating on the specific educational and training Foxconn will need to fulfill its manufacturing needs with Wisconsinites.

The group was told that Foxconn will result in no tax increases in the village or county. They anticipate property values to increase and as that occurs the county and village will evaluate the mill rates and overall property taxes.

NOTE: Personally I suspect many parts of WALCO will become bedroom communities and our property values may go up. Maybe now is the time to start talking to our own local elected officials.

Foxconn for each acre of wetland used will replace it with 2 acres. Both the executive and president were adamant that Foxconn is incredibly environmentally friendly and will abide by or exceed EPA and Wisconsin DNR standards voluntarily.

One of the questions was in regards to water from Lake Michigan use. According to the executive and president, if I heard them correctly, Foxconn will use less water from Lake Michigan than all of the breweries combined back in the heyday of brewing in Milwaukee.

Foxconn is going to be huge for us. Any candidate for office who says they will shut down Foxconn or it's a corporate give-away, I believe is very mistaken and uninformed.
