EXCLUSION OF LIABILITY, RELEASE AND ASSUMPTION OF RISK

ENRANTS / DRIVERS / RIDERS / CREW / Passengers: must read and sign before being allowed to compete.

I have read the Supplementary Regulations* issued for this Event and agree to be bound by them and by the rules of the Australian National Drag Racing Association Ltd. I also acknowledge and agree as a condition of entry that neither the Australian National Drag Racing Association Ltd, Mid Coast Drag Racing Association nor the promoters, nor the sponsor organisations, nor the land owners or lessees, nor the organisers of the racing event, nor their respective servants, officials, representatives or agents (all of whom shall collectively be called the "Associated Entities"), shall be under any liability for my death, or any bodily injury, loss or damage which may be sustained or incurred by me as a result of participation in or being present at the event, except in regard to any rights I may have arising under sections 60 & 61 of the Australian Consumer Law 2010 (Cth). I acknowledge that motor racing is dangerous and that accidents causing death, bodily injury, disability and property damage can and do happen.

In exchange for being able to enter, attend or participate in the event I/we agree:

- To release ANDRA, Mid Coast Drag Racing Association the promoters, sponsor organizations, land owner's, organizers of the event, their respective servants, meeting director and officials (collectively the "Associated Entities) from all liability for my death, personal injury (including burns), psychological trauma, loss or damage (including property damage) ("harm") howsoever arising from my participation in or attendance at the event, except to the extent prohibited by law.
- That ANDRA and the Associated Entities do not make any warranty, implied or express, that the event services will be
 provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for
 which they are supplied; and
- To attend or participate in the event at my/our own risk.

I/We acknowledge that:

- the risks associated with attending or participating in the event includes the risk that I may suffer harm as a result of:
- motor vehicles/motor cycles (or parts of them) colliding with other motor vehicles/motor cycles, persons or property;
- acts of violence and other harmful acts (whether intentional or inadvertent) committed by persons attending or participating in the event: and
- the failure or unsuitability of facilities (including fences and guard rails) to ensure the safety of persons or property at the event.
- Motorsport is dangerous and that accidents causing harm can and do happen and may happen to me/us.

- 1. Please return the completed and signed application form to: mcdra2018@gmail.com
- 2. <u>All payments to be made payable to</u>: Mid Coast Drag Racing Association

- 3. Pre-entries and payment are to be received no later than one week before the event. You may be able to enter on the day, however there is no guarantee that entries will be available, given that we are can only take a maximum of fifty (50) vehicles. This is a Council and MCDRA requirement.
- 4. Once your entry has been processed and your payment confirmed, you will receive a confirmation email from MCDRA, including a receipt/entrant number.
- 5. Arrive at Taree Airport (1 Lansdowne Road, Cundletown) between 8 and 9am on race day. Enter via the service access, approx 200 metres north of the roundabout on Manning River Drive. No access is available from the Terminal.
- 6. Present your receipt/entrant number when you arrive at the ticket booth. Staff will direct you (and up to two crew members) to proceed to the scrutineering area in the pits. Additional people in your group will need to pay the spectator fee.
- 7. Once you arrive at the scrutineering area, wait with your vehicle (bonnet up).
