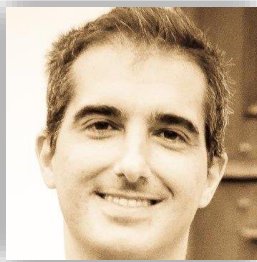


**Jasmine Sliger

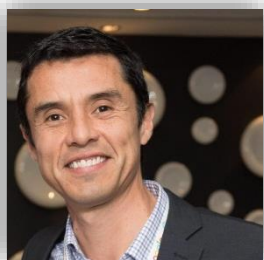
