As a business vendor for The Center for Animal Health & Welfare's Paws for a Cause event on Saturday, May 20, 2017, I understand that:

- I agree to set up and manage a vendor area from 12:00 p.m. – 4:00 p.m.
- Vendors may begin set up at 10:00 a.m.
- The scheduled rain date for the event is Saturday, May 27, 2017, from 12:00 p.m. – 4:00 p.m.
- I am responsible for bringing my own tent (no larger than 12 x 12), chairs, tables, and electricity generator if needed.
- I will be responsible for providing a raffle item/basket to be raffled off the day of the event, and a \$25 non-refundable vendor fee paid in full prior to the event. You may choose to donate \$50 in lieu of a raffle item.
- I am responsible for set up, tear down, and clean up of my vendor area.
- I am encouraged to help publicize Paws for a Cause via social media, email, and any other advertising I am able to do. Flyers and event graphics will be made available from CAHW upon request.
- Please note that by agreeing to participate, you hold yourself responsible for all actions and potential injuries, not the hosting facility, the organizers, or any other party.
- I understand that it is suggested that a waiver of insurance liability be in place for participation in the event.
- I declare, on behalf of my business or organization, that we will be held liable for any damage or destruction done by our participants at the event.
- On behalf of _____ and in recognition of the risk of incident while participating in the event, as consideration for the right to participate in the event, I hereby for myself, my heirs, executors, administrators, assigns, or personal representatives knowingly and voluntarily enter into this waiver and release of liability (Agreement) and hereby waive any and all rights, claims or causes of action of any kind whatsoever arising out of my participation in the event, and do hereby release and forever discharge Paws for a Cause and its affiliates, managers, members, agents, attorneys, employees, volunteers, heirs, representatives, predecessors, successors and assigns, business and its affiliate managers, members, agents, attorneys, employees, volunteers, heirs, representatives, predecessors, successors and assigns, the Event site and its agents, attorneys, employees, volunteers, heirs, representatives, predecessors, successors and assigns, and all sponsors and/or beneficiaries of the Event (collectively hosts) from any and all liability, claims, demands, damages, actions, or causes action now existing or which hereinafter may arise as a result of my participation in the Event, whether any injury is caused by the negligence of the Hosts, the negligence of myself or third parties, the conditions of the Event or any other cause.
