## Show Information & Event Barn Rules

#### 1. Health Records:

All horses <u>must be vaccinated</u> for **Strangles** within the past six months to seven days of the show date or have titer paperwork and signed note from veterinarian. Horses must have a current negative **Coggins** and be vaccinated for **Equine Influenza Virus** and **Equine Herpes Virus** (Rhinopneumonitis) vaccinations within six months prior to entering the stables. Please mail a copy of your coggins with your entry fee or bring accompanying documentation to the show office when you check in. Horses that cannot receive vaccinations for medical reason are exempt with a signed letter from a veterinarian. See attached information on the vaccination rule and the USEF vaccination form.

## 2. Directions:

From Huffine Lane in Bozeman, turn South onto Cottonwood Road for 4 miles, turn right onto Johnson Road for 0.6 miles, and turn left onto Van Dyke Road for 0.4 miles. From the South, turn right onto Gooch Hill Road for 3 miles, turn right onto Johnson Road for 1.5 miles, and turn right onto Van Dyke Road for 0.4 miles.

The private easement speed limit is 15 mph, please drive slow and respect the neighbors. Please park in the designated area for your vehicle.

Please respect our neighbors and <u>do not ride horses or drive south on Vandyke road</u> past the Tri-H entrance. Do not drive to Tri-H from the south on Vandyke road. Thank you.

## 3. Schooling Day Before:

Schooling is available the day before the show, for an additional fee. You may school in the warm up arena and dressage arena. You must sign the BDS assumption of risk form and Tri-H release form prior to mounting. Anyone mounted on a horse anywhere on the property, and not competing in a show that day, is considered to be schooling. Please mail the release forms and schooling fee with your entry if you plan to school the day before as BDS office volunteers may not be on site when you arrive and wish to school.

## 4. Warm-up:

Day-of show warm-up schooling is allowed all day in the designated warm-up arena and around the perimeter of the dressage court prior to the show.

## 5. Bridle Tags Required:

All horses must submit an entry form and wear the assigned bridle tag at all times while on the show grounds day-of show. You must check in with the show office and have a bridle tag on your horse prior to mounting, day-of show. Please return tags at end of day.

## 6. Arenas:

We will have the use of two large outdoor sand arenas. The warm up arena is located in the large outdoor arena. Dressage tests will be ridden in the outdoor dressage arena, full court. In case of inclement weather, the show will be moved to the indoor arena, full court.

## 7. Main Barn Off-limits:

Please respect that indoor arena and main barn facilities are for the use of the boarders only. Please do not take horses into the main barn.

#### 8. Haul-ins:

Haul-ins are allowed for horses staying no longer than 3-hours at the facility. All haul-in horses must follow these rules, or be moved to a stall and charged the stabling fees:

- a) Horses tied to trailers must be supervised at all times.
- b) Horses must not be allowed to dig holes in the gravel.
- c) Horse manure must be cleaned up immediately.

#### 9. Stabling:

Stalls will be assigned and a list posted in the show barn. Indicate stabling group on your entry. Please coordinate the use of one group name for your entire group. No shavings are included in the stall fee. Shavings bags may purchase on site; outside shavings not allowed. Please indicate number of bags on your entry, and they will be provided for you at your stall.

You are responsible to bring your own water buckets, bucket hangers, bridle and saddle racks, hoses, wheel barrows, and pitch forks. Stalls must be mucked clean before you leave. Stall and manure, bedding, and feed may be deposited on site in the manure bins.

A \$25 clean stall deposit is required with your entry. Deposit checks will be returned upon stall inspection before you leave, and will be cashed for stalls that are not left clean. Facility preference is that you clean your stalls as staff time is limited. Please leave the grounds as you found them. Tack stalls are available. Stall fee includes arrival the night before. See ground fees for pricing.

#### 10. Hay:

Quality hay is readily available for purchase on site. Indicate desired bales on your entry and they will be provided for you at your stall. You may bring your own hay as well.

## 11. Camping:

Camping is allowed. There are 8 RV hookups with electricity, one with a hose. Four 50amp and four 30amp hookups. There are plenty of dry-camping spots available. Please make reservations on your entry form.

## 12. Accommodations:

The closest hotels to Tri-H will be located on North 19<sup>th</sup> Avenue in Bozeman. If you want to be really close to Tri-H, look for a bed and breakfast or vacation rental, of which there are a few nearby.

## 13. Restrooms:

Portable restrooms are located in the East side of the show barn.

- 14. **Concessions** will not be available during the fix-a-test show. Please bring your snacks/meals.
- 15. **BBQ's are not allowed** on the show grounds.

## 16. Smoking and Pets:

No smoking on show grounds! Dogs must be leashed at all times and owner is responsible for any damage or injury caused by the dog on the show grounds. Please pick up after your dog.

## 17. Noise:

Please be quiet while exhibitors are riding their tests. Sudden noises, crinkling of food wrappers, etc can spook and distract horses.

## 18. No Flash Photography:

No flash photography is allowed in the indoor arena.

#### 19. Garbage:

Please dispose of all garbage in the designated trash bins.

#### 20. Helmets:

Required. Anyone mounted at any time must wear ASTM/SEI approved helmets.

## 21. Awards & Ribbons:

All score cards must be picked up day of show, and will be available throughout the day. 1-6<sup>th</sup> place ribbons will be provided.

## 22. Attire:

At a minimum, riders shall present a respectful tidy appearance.

23. Tack:

No boots, bell boots, or polo wraps allowed. Regulation bits, appropriate for your division, required. <u>Hunter/Jumper and Western saddles are allowed</u>.

All participants must comply with the Tri-H Stables Rules and regulations and the directions and instructions given by the BDS Club.

## 27. Show Office:

The show office, announcer, vendors, and prize booth will be located on the South side of the indoor arena, just inside the large garage doors, opposite the large outdoor arena. The

office will be open at 11:00am day of the show and close a half-hour after the completion of the final class. Show start time, and ride times, will be announced the week of the show. Check-in and receipt of bridle tag is required prior to mounting day-of the show.

In consideration of my participation in clinics, lessons, shows, and/or general handling and training of horses, as well as any boarding or stalling of my horse(s) and any use of grounds or arenas owned or leased by TRI-H Stables, LLC of 400 VanDyke Road, Bozeman, Montana 59718 (collectively "Horse-Related Activities"), I hereby waive, release, and forever discharge any and all rights, claims, demands and causes of action for injuries, damages, liabilities and responsibilities, which I may have or which may hereafter accrue to myself or my horse(s) against TRI-H Stables LLC, and its agents, representatives, members, owners, employees, trainers, clinicians, volunteers, affiliates, and/or sponsors and the successors, heirs and assigns of the foregoing ("collectively the Released Parties") for any and all injury and damages which may be sustained by me or my horse(s) as a result of any Horse-Related Activities. I recognize that horses are large, dangerous, and unpredictable animals, and that there are significant risks of serious injury and death inherent and associated with horses and Horse-Related Activities, including but not limited to trailering, boarding, stalling, riding, training, participating in lessons, grooming, saddling, feeding and caring for horses. Knowing the inherent risks, dangers and rigors involved in such Horse-Related Activities, I certify that I understand the risks associated therewith, that I am fully capable of participating in Horse-Related Activities, including lessons and clinics, that my horse(s) is sound and is able to participate in the training requested, and that I am requesting participation in Horse-Related Activities at my own risk. I further agrees that I will not, at any time hereafter, either directly or indirectly, initiate, assign, maintain or prosecute, or in any way knowingly aid or assist in the initiation, maintenance or prosecution of any claim, demand or cause of action at law or otherwise, against the Released Parties for damages, loss or injury of any kind arising from, related to, or in any way connected to my participation in any Horse Related Activities sponsored, provided, or organized by Released Parties or resulting from my use of equipment, facilities or machinery provided by any of the Released Parties. I have a duty to act in a sage and responsible manner at all times to avoid injury to me and to others and to be aware of risks inherent in equine activities. Section 27-1-727, MCA, et seq. \_\_\_\_\_ (initial)

I agree to comply withal BDS rules and regulations, including those given verbally and in writing, and participate in any safety meetings and the presentation of any safety materials that are designed and offered to promote safety in equine activities. \_\_\_\_\_\_ (initial) I, or my parents/legal guardian if I am a minor, agree to pay all costs incurred by BDS, the facility or its agents, for damages incurred as a result of me or my child's willful or negligent conduct while participating in equine activities sponsored by BDS\_\_\_\_\_ (initial)

I further certify that if I provide an equine for an activity, I certify that the equine is appropriately trained for that activity and that I am able to maintain control over the equine to prevent danger to myself and to others. 

Windhorse Equine Learning is a nonprofit 501(c) (3) organization that provides equine-assisted learning (EAL) experiences to Bozeman-area youth ages 8-17. The Windhorse program is especially beneficial to youth who are in transition, struggling with relationships, communication, or academics, those who lack confidence or suffer from anxiety. Windhorse is offered in 6-week sessions during the spring and fall and in week-long summer camps held in partnership with MSU's Equine Science Program and the Gallatin Valley YMCA. Windhorse provides scholarships to all families in need of assistance.
