Workshop Fee: \$250 for two days

If you will offer your Sun 73 instruction through an Area Agency on Aging or SASH, we can invoice your organization, but please check with them before filling out this registration to be sure they'll cover the cost of the workshop.

Fee includes two days of instruction, snacks and beverages, along with free skillbuilder workshops throughout the term of your two-year certification. There are local places to buy lunch, or you can pack your own (fridge is available).

Day one (Sat.) will be devoted to intensive work on the Sun 73 form and the best ways to teach it.

Day two (Sun.) will include a teaching practicum where new instructors can teach class participants in small groups with supervision from Marty Kidder.

Certificates will be awarded at the end of day two.

(Note: Class participants for day two—that is, people NOT seeking certification—will register separately at a cost of \$50. We encourage you to promote this learning opportunity to your own current students.)

Important Note: When you certify or recertify in Sun 73 you receive automatic recertification in all segments of Tai Chi Vermont's Fall Prevention Tai Chi. To be super clear about this—you do not need to also take recert in FPTC.

It's our sincere hope that everyone coming to the workshop will receive full certification or recertification. However, if Marty believes an individual needs more training before he or she can be a safe and effective teacher of Sun 73, a provisional certificate will be issued, with instructions on what to do so that full certification can be gained.
