

Albizia Law SB 464

RELATING TO
PRIVATE PROPERTY.

Report Title: Private Property; Albizia Trees; Control; Safety

Description: Authorizes a property owner or agent to enter adjacent property with albizia trees under certain conditions, including consulting with a tree arborist and providing written notice, to control albizia trees before they become hazardous. Provides a defense to criminal prosecution. (SD2)
