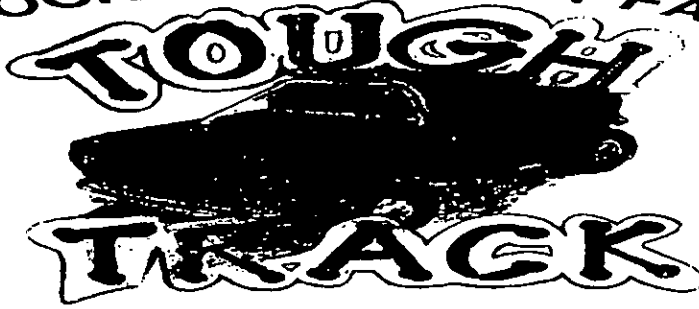

3. Driver must wear seat belt, helmet and have working brakes.
4. All tires must be street legal. No tractor tread tires allowed.
5. No motorcycles or ATV vehicles allowed. Must be production.
6. Track judges rules are final.
7. Any problems that arise with members of the pit crew will result in that person(s) being ejected immediately from the pit area along with the disqualification of the driver.
8. There will be a safety inspection.
9. Each driver has two (2) runs. Best time of two runs used to determine the winner.
10. Roll bars recommended.
11. Jeeps and soft top type vehicles roll bars required.
