



Zombie Zone (subsequently to be referred to as “the Event”) is a real life role play theatrical event that should be entered into with a spirit of fun and play. While competitiveness is an element of the event we expect all participants to display good sportsmanship, honesty and fairness. The event will take place in the Gluttony grounds which is an outdoor venue. Being a functioning public space all players will encounter various obstacles. It is the responsibility of each play to negotiate these obstacles safely during the course of game play.

Likeness Release

By participating in the Event I agree to Last Dodo Entertainment (subsequently to be referred to as “the Organisers”) to record my person and my actions throughout the Event. Said images and footage may be used for promotional, broadcast, media or any other form of distribution as seen fit by the Organisers unless specifically restricted by Privacy Laws.

Voluntary Assumption of Risk

By participating in the Event I understand that all participants, including myself, may be at risk of injury and fatality from a variety of causes including, but not limited to, accidents with other players, accidents with non-participants, weather influences, ground topography or other factors. I accept that my participation could lead to injury or death and accept all responsibility for my actions.

Liability Release

I indemnify the Organisers from all claims and demands or proceedings that may arise from my participation in the Event. This includes, but is not limited to, liability for their negligence or the negligence of other participants. This pertains to injuries, loss or damage of property or loss of life. This indemnity extends to the Organisers, their agents and officers, the Venue, partners, sponsors, contractors, volunteers, security, licensees and occupiers of the grounds where the Event is hosted. The release exists in perpetuity and binds my next-of-kin and all legal representatives. This waiver does specifically exclude the participant from Liability for ordinary negligence in the performance of the Event and the application of provisions specifies in Subdivision B of Division 1 of Part 3-2 of the Australian Consumer Law and the participant shall be excluded from liability under any civil claims or consumer laws that apply in the State in which the Event is performed, as is permitted under the law.

Physical Disclaimer

I state that I am physically capable to participate in the Event. I’m not aware of any medical or physical reason that I should not complete my participation in the Event. I acknowledge that I am capable of monitoring my physical condition during the Event and will immediately remove myself from participation if my continued involvement will result in injury for myself or others. I further give permission for the Organisers to have medical officers provide first aid or medical treatment as they see fit in the event of misadventure. If emergency transportation is required I agree to accept responsibility for all costs and those associated with subsequent treatments.

Drugs and Alcohol

I understand that it is prohibited to be under the influence or, or to consume during the course of the Event, any illegal drugs. I further agree that, while limited consumption of alcohol prior to the start of the Event is allowed, if I display any symptoms of adverse capacity resulting from alcohol consumption I will be removed from participation.

Acknowledgement of Understanding

I have read the above and understand its contents. I confirm that all the information I have presented is honest and true to the best of my knowledge. I have not misrepresented my abilities. I have entered into this agreement voluntarily. I understand that in signing this document I am explicitly giving up substantial rights including the right to sue the Organisers and other ancillary organisations.
