(VST filters on EFI engines require additional labor) Remove and replace distributor cap and rotor (where applicable). Check and top off all critical fluids. Inspect drive belts and hoses (where applicable) Lube all grease points. Remove, clean and reinstall flame arrestor. Remove and replace zinc anodes (where applicable) Start engine, check and adjust timing, idle, throttle and shift controls as necessary.

BY SIGNING THIS SERVICE CONTRACT YOU AGREE TO ALL TERMS AND CONDITIONS AND OR SHOP POLICIES OF JM MARINE SERVICES, INC. IT IS ALSO UNDERSTOOD AND AGREED THAT AN EXPRESS MECHANICS LIEN WILL BE IMMEDIATELY PLACED ONTO THE ITEM FOR SERVICE TO SECURE THE AMOUNT OF THE DEBT ON ANY AND ALL BALANCES PAST 30 DAYS DUE. LATE FEES AS WELL AS FINANCE CHARGES WILL APPLY TO ALL OUTSTANDING BALANCES

1. All bills are DUE UPON RECIEPT. Items in for repair will not be released until paid in full. A late fee of \$25.00 will be applied to all open invoices past 7 days of invoice date. As well a finance charge of 2% a month (24% annually) on any outstanding balances. NO EXCEPTIONS. In the event collection services are required to collect a debt, you will be charged any and all costs involved in collecting the debt. Including, but not limited to lien filing fees, collection company fees and or attorney fees.
2. No work shall be performed without a signed contract or work order.
3. Any transient boats in for repair and left for 7 days after the notification of the completion of contracted work will be charged a storage fee of \$2.00 per foot, per day, in addition to any and all late fees and finance charges. Liens will be filed after 30 days of nonpayment. Lien filing fee of \$500.00 will apply. NO EXCEPTIONS.
4. Any engines, jet skis, trailers etc. in for repair and/or removed from vessel that are left at our facilities will be charged a storage fee of \$150.00 for each item per month.
5. We reserve the right to reject any work order or contract upon inspection of engine and/or vessel.
6. Positively no tools loaned.
7. Customer agrees that JM Marine Services and its employees may operate the unit on any waterways or elsewhere for reasons of testing at the owners own risk.
8. Customer agrees that JM Marine Services and its employees are not responsible for loss or damage to the unit by way of fire, theft, accident, inclement weather or any other conditions beyond our control.
9. AFTER 14 DAYS OF NONPAYMENT OF REQUESTED WORK, YOUR BOAT WILL BE HAULED OUT AND BLOCKED AT OWNERS EXPENSE IN ADDITION TO ANY OUTSTANDING BALANCES. BOATS WILL NOT BE RELAUNCHED UNTIL ACCOUNT IS PAID IN FULL. NO EXCEPTIONS.
