50-YEAR REVIEW OF INDUSTRIAL WASTEWATER TREATMENT TECHNOLOGY AND WHAT STILL WORKS

(retired), will present a 50-Year Review of Industrial Wastewater Treatment and future trends. Mr. Goodman is an internationally recognized water and wastewater expert with a focus on large water reuse industrial treatment projects. Al is a tremendous

asset to the industry and serves as the Chairman of IIOA Board of Directors. He is a past president of WEF and the Indiana Water Environment Association. The Keynote presentation will be held on April 4 at 10:00 am in the Industrial Concurrent Session.

A Wastewater Case Study was presented reflecting on the challenges and accomplishments of EMC Precision.

The Awards were presented on Thursday during the Combined Session with over 230 in attendance. Accepting the Award for EMC was Travis Watson, Jeff Ohlemacher and Christopher Catron (Industrial Operator of the Year) EMC.

Industrial Operator Award of the Year - Christopher Catron

Chris has been an IIOA member operator for over 20 years. He holds a Class C Indiana Industrial Operator License. In 2000 he was awarded an individual operator award. Under his management, the Industrial Plant was upgraded and decreased water usage thereby reducing the plant classification from a Class C to Class B plant. This has resulted in conservation of water resources. Chris oversees the in-house QA/QC laboratory, wastewater treatment, and manages the RCRA hazardous waste program. His plant has a continuous operation hydroxide precipitation metal removal system with chromium reduction, coagulation, flocculation, pH adjustment and solids removal. Effluent is discharged to the city of Sheridan, IN.

IDEM Deputy Assistant Commissioner, Robert Lugar congratulated Becky Ruark on her Environmental Stewardship recognition award in the presence of 230 water quality professionals at WITtec. Becky has worked since 2006 as an IDEM wastewater facility inspector and overseen the DMRQA laboratory proficiency testing program since 2008. She also does technical review of the wastewater operator exams. Before coming to IDEM she worked for seven years in the labora-

tory and in industrial pretreatment for the City of Richmond. Becky earned a Master of Science in Management degree from Indiana Wesleyan University and a Bachelor of Science degree in Biology from Indiana University East. She holds both an Indiana Class IV municipal and Class D industrial wastewater operator certification. In April Becky presented a technical presentation on the DMRQA Program at WITtec.
