Rent: By signing this agreement, you are agreeing to leave your handmade Art and/or Crafts at Every Nook + Cranny, for the required minimum of 3 months. If, after three months, our management deems that your product is not a good fit at this location, we will ask you to remove your product and end this contract at any given time after your required three month term. Rent is automatically deducted from each account on the 1st of each month. Profits for the previous month will also be paid on the 1st of the month and checks will be available for pick-up AFTER 2:00pm. If you would like your check mailed to you, please supply us with a self addressed stamped envelope. If your sales do not cover your monthly fees, it is your responsibility to cover the difference owed each month. If you are delinquent in paying monies owed, without prior arrangement being made, your products become property of Every Nook + Cranny.

Commission: A 25%-35% commission will be deducted from each sale depending on the agreement of terms.

Responsibility: All crafts must be handmade and MUST be approved before they are allowed to enter the store. We try to keep competition to a minimum between artists, crafters, and vendors; therefore duplications of product that is currently in the store will need to be reviewed.

WE ARE NOT RESPONSIBLE FOR THEFT, FIRE, WATER DAMAGE, OR ANYTHING ELSE BEYOND OUR CONTROL.

Sales Tax: As required by law, sales tax will be collected on all rental space and on all crafts sold. If you are signing a one-year contract with Every Nook + Cranny; sales tax is not required by law. We will assume the responsibility of paying these monies to the state for each Vendor, Artist, or Crafter.

Tags: All items **no matter how small** must be labeled with your Vendor Number, Description (if needed for your own inventory management), and Product Price. Tags WILL NOT not provided by Every Nook + Cranny—this is something you will provide yourself, all tags must be easily removable from product.

Lists: Each time you add or remove an item from the store, we need an inventory list for your file.

Art/Craft Shows: No shelves are to be emptied for the purpose of taking crafts to a craft show for inventory.

Exclusive: Crafters cannot lease space or sell wholesale to any shop within a 15-mile radius of Mt. Dora.
