



Snake River Juniors Volleyball Club 2018 Financial & Membership Agreements

Please read this agreement carefully. It describes the financial responsibility and obligations that come with membership/participation in the Snake River Juniors Volleyball Club (SRJ).

Club Dues/Fees:

Your dues cover the club's expenses for practices, training development, facility, equipment, coaches' compensation, tournament entry fees, ERVA/USA volleyball fees, technology/software and administrative and operational costs.

Payment Plan: Our payment plan is designed to allow families to budget for the season. The following payment schedule is offered as a minimum payment plan:

- Initial payment: 50% of base club fee is due at commitment night – November 16, 2017
- Final payment: The final payment (50%) is due on or before the Rules and Scoring Clinic: TBD – Feb 2018

The 2018 Club Base Fees

\$450.00: U14-1, U16-1, U18-1 Teams

***Fee covers ALL tournament entry and coaching costs to attend six (6) tournaments**

\$350.00: U14-2, U16-2, U18-2 Teams

***Fee covers ALL tournament entry and coaching costs to attend five (5) tournaments**

\$300.00: U14-3/4, U16-3/4, U18-3/4 Teams

***Fee covers ALL tournament entry and coaching costs to attend four (4) tournaments**

\$275.00: All U12 Teams:

***Fee covers ALL tournament entry and coaching costs to attend four (4) tournaments**

**Costs to attend additional tournaments are billed separately from the membership fees listed above.
Players are responsible for their own travel arrangements and costs.**

Player Eligibility:

SRJ Volleyball Club is required to pay, in advance, fees such as: ERVA/USA volleyball memberships for teams, chaperones, coaches, tournament entries, etc... The timeliness of payments is important and necessary. All fees must be paid as outlined above before any athlete/player will be allowed to begin the season.

Additional Travel/Tournament Fees:

- Teams may choose to participate in additional tournaments beyond tournaments included in the base club fee. All expenses associated with attending these tournaments are an additional cost to players and billed separately. SRJ accepts no liability for costs associated with travel, parking, hotel, meals or incidental expenses incurred while participating in additional tournaments.

Payment Options:

- Debit Card Payments: There is a 4% transaction fee to use this payment method.

Refunds:

There are **NO REFUNDS**. No refunds shall be given for dues, uniforms, deposits, special event/travel tournament expenses, equipment, etc. Once you sign this agreement you are financially committed and responsible for the full amount of the club dues and any balances on your account regardless of attendance to tournaments. This includes, but not limited to players choosing to leave the program, conflicts with other sports, illness, vacations or being removed from the program for disciplinary reasons.

*Exception: SRJ may consider special circumstances in the case of season-ending injury. In this case, please contact the Club Director(s) for review and consideration. **No other exceptions will be considered.***

Failure to Comply:

Should any player/family choose not to comply with the terms of this agreement, SRJ Volleyball Club reserves the right to pursue any member through legal proceedings or collection services for non-payment of dues or any associated fees owed to SRJ. Such actions may result in adverse effects on the member's credit score and/or credit history. In addition, any expenses related to legal and/or collection agency fees incurred by SRJ Volleyball Club will be included.

By signing this agreement, you are committing to the full payment of all dues/fees, uniforms, and travel costs charged to you for the season. By signing this agreement, I, the athlete/player's parent or guardian, confirm that I have read, understand, and agree to all the conditions of this agreement entered into with Snake River Juniors Volleyball Club.

- I AGREE NOT TO SUE any of the persons or entities listed above for any of the claims or liabilities that I have waived, released or discharged herein; and
- I INDEMNIFY AND HOLD HARMLESS the persons or entities mentioned above from any claims made or liabilities assessed against them as a result of my actions.
