PARTICIPANT AGREEMENT, INDEMNIFICATION, GENERAL RELEASE AND ASSUMPTION

(PLEASE READ THIS DOCUMENT THOROUGHLY! BY SIGNING IT, YOU ARE WAIVING YOUR'S AND/OR YOUR WARDS' LEGAL RIGHTS)

In consideration of being allowed to participate in the services and activities, including, but not limited to, seated room-scale virtual experiences, standing room-scale virtual experiences, full room-scale virtual experiences, and any other amusement activities (collectively "*EXPERIENCES*"), provided by DREAMWEAVR GAMING, LLC and its agents, and any and all other persons and entities acting in any capacity on its behalf (collectively "*DreamWeaVR*"), I hereby agree to forever release, indemnify and discharge *DreamWeaVR* on behalf of myself, and all other persons who could in any way represent me, and/or on behalf of my minor child(ren)/ward(s), or act on the behalf of myself, and/or on behalf of my minor child(ren)/ward(s) as follows:

I. RELEASE OF LIABILITY: Despite all known and unknown risks, I hereby expressly and voluntarily release, and forever discharge *DreamWeaVR*, and agree to hold it harmless of and from all, cause and cause of action, judgments, claims and demands whatsoever, in law or in equity, including, but not limited to, any and all claims which allege negligent acts and/or omissions committed by *DreamWeaVR*, regardless the action arises out of any loss, personal injury, or death to myself, and/or my minor child(ren)/ward(s), while participating in or as a result of participating in any of the *EXPERIENCES*.

II. INDEMNIFICATION: I hereby agree to indemnify and hold harmless from and against any and all losses, and/or expenses whatsoever paid by *DreamWeaVR*, including, but not limited to, any and all attorneys' fees, and/or judgments *DreamWeaVR* incurs in the event that I, and/or my minor child(ren)/ward(s) cause any losses to *DreamWeaVR* and/or any entities acting in any capacity on behalf of *DreamWeaVR*.

III. DIGITAL MEDIA RELEASE: By entering into a service agreement with *DreamWeaVR*, I hereby grant *DreamWeaVR*, on behalf of myself, and/or on the behalf of my minor child(ren)/ward(s), the irrevocable right and permission to photograph and/or record myself, and/or my minor child(ren)/ward(s), as well as, re-project my image, and/or the image of my minor child(ren)/ward(s) within a virtual environment, and to use the imagery and/or recording for all purposes, including promotional purposes. I waive any right to inspect or approve the use any media capture of myself and/or my minor child(ren)/ward(s), and acknowledge and agree that the rights granted to this release are without any compensation.

V. TERMS OF AGREEMENT: I understand that this agreement extends forever into the future and will have full force and legal effect each and every time I, and/or my child(ren)/ward(s) participate in *EXPERIENCES* provided by *DreamWeaVR*, whether at the current location or any other location or facility.

VENUE/ARBITRATION: I agree any suit brought against *DreamWeaVR* shall be arbitrated within Henrico County, and the substantive law of the Commonwealth of Virginia shall apply without regard to any conflict of the rule of law. I also agree that if any portion of this agreement is found to be void or unenforceable, the remaining portion shall remain in full force and effect.
