2017 Pumpkin Pie Contest Rules & Regulations

1. **TURNING IN ENTRIES-** Finished baked goods must be brought to the Schlader building by **October 7th, 2017 at 11am** to be considered for judging. A Photo ID will be required for the Adult Competition and an adult must accompany a child for the Junior Competition with Photo ID as well.
2. **INGREDIENTS-** All baked pies must include pumpkin as the main ingredient (not pumpkin spice).
3. **JUDGING-** Entries will be judged on TASTE, ORIGINALITY, AND PRESENTATION. If a tie occurs, the competitor with the highest score for taste will win. If there is still a tie, the judges will sample those pies again and select their favorite.
4. **CLEANLINESS & SANITATION-** Competitors are to prepare their baked goods in as sanitary manner as possible. Competitors WILL be required to taste their entry **AFTER** the presentation judging, but **BEFORE** the taste and originality judging. Refusal to taste your entry will result in disqualification.
5. **MISCELLANEOUS INFORMATION-** (1) Registration is not considered “complete” until the form is filled out and entry has been submitted on **October 7th, 2017**. (2) Plates, napkins, and silverware will be provided for the judges. (3) Slices will be cut **AFTER** judges have completed the presentation portion of judging.
