- Dessert must be prepared onsite, must include some wood fired cooking of some sort, and must include apples in some fashion.
- Must contain 6 portions (minimum) but does not have to be cut into servings (for example, cake or pie may be presented whole).
- No garnish is required.
- You are not required to turn entry in using the standard Styrofoam container; however, we are not responsible for returning containers to teams. The number from your container must be placed on your entry and it cannot be larger than can be carried with one hand.
- Entries will be judged in the usual KCBS format for appearance and taste, but instead of tenderness it will be judged on the creativity of the entry.
- 1st Place prize receives \$100
- Turn in is 6:30pm on October 5, 2018

Anything BUTT Rules:

- One free entry per team
- Any food is permitted except one of the 4 main meat categories. Food must be prepared onsite and any form of cooking is permitted. Each entry must contain at least 6 portions.
- No garnish is required.
- You are not required to turn entry in using the standard Styrofoam container; however, we are not responsible for returning containers to teams. The number from your container must be placed on your entry and it cannot be larger than can be carried with one hand.
- Entries will be judged in the usual KCBS format for appearance and taste, but instead of tenderness it will be judged on the creativity of the entry.
- 1st Place prize receives \$100
- Turn in is 6:00pm on October 5, 2018

Professional BBQ Contest:

- There will be four (4) separate categories in the BBQ Contest [1. Chicken, 2. Pork Ribs (loin or spare), 3. Pork (Boston Butt/Picnic/Whole Shoulder) and 4. Beef Brisket]. **To be in competition for Grand Champion and Reserve Champion, a team must have entries in all four categories.**

ENTRY FEE: \$250.00 to enter all categories. Standard BBQ Team space is 20' by 40'. 20lbs of ice will be provided to all Professional BBQ Teams additional space by request for an additional fee. Electricity 110/20 amp included, extra amp available for an additional charge.
