- Please have your hair clean, dry & free of products.
- Face completely clean, moisturizer only.
- Please research & bring pictures for inspiration of your desired wedding day look.

SPECIAL INSTRUCTION SHEET FOR BRIDAL GROUP

Your wedding day is quickly approaching & Salon G could not be more excited to be a part of your big day! The following is a list of pointers to share with your bridal party in order to ensure your wedding morning is stress free, organized & enjoyable!

- If you are getting ready at a hotel, please text or email Gina the evening before with the room # &/or any special instructions.
- Please review and inform all members of the party of the prices.
- In order to stay organized please ask all of the attendants to arrive on time.
- For an Up-do: Please have hair clean and dry, parted on the desired side of the style. Also wear a buttoned down shirt to better insure that the hair will not be hindered by any removal of clothing. If hair is curly & a clean smooth style is desired, please have hair straightened or blow dried prior to your service. Pictures for inspiration are appreciated.
- For make-up applications: Please have clean, dry, moisturized skin, free of acne creams. Also wear a button down shirt to better insure that the make-up will not be hindered by any removal of clothing. If receiving airbrush foundation, please remove earrings and jewelry prior to service. Make sure to advise Salon G of any skin sensitivities, allergies or other issues.
- Although Salon G is fully equipped with all necessary products, if you or a bridal attendant have any specific product preferences such as mascara, eye liner, foundation or a certain hair product, please feel free to bring that product along.
