In consideration of the permission given to this vendor by the Tarrant Chamber of Commerce and TMI Productions to use certain specified premises inside the City of Tarrant, Alabama, for the purpose of exhibiting and/or selling on the Festival date of this year, this vendor on behalf of him/herself, employees, members, customers, and invitees hereby agrees that the premises are to be used and enjoyed at his/her own risk and agrees to save and hold harmless the Tarrant Chamber of Commerce, TMI Productions, and the City of Tarrant and any members, employees, agents, and representatives from and against all liabilities, damages, cost fees and expenses or action suits, demands, judgments, and claims of any nature or in any manner arising from, by reason of, or in connection with injury to/or death of persons or damage to property in any manner arising from the use or occupancy of the premises by the vendor or resulting from a condition of the premises or weather-related conditions on move in/setup day or day of Festival. A signed application constitutes a contract to follow all the rules and regulations and is a commitment to participate if accepted. Fees are nonrefundable. Violations of rules and regulations will result in the closing of the vendor's location for the duration of the Festival, without refund, and the applicant may be excluded from future Five Mile Creek Festivals. A current copy of the vendor's permit from his/her local health department must accompany application. Acceptance of application does not guarantee exclusive sales of any food menu or items. At no time does TMI Productions, Tarrant Chamber of Commerce, or the City of Tarrant extend exclusive rights to any food vendor or their menu items.

No application will be considered unless completed, signed, and accompanied by the appropriate fee and/or agreement. Each vendor is responsible for collecting sales tax and reporting it to the State of Alabama.
