GENERAL PROVISIONS

§ 150.01 IMPEDING FLOW OF WATER PROHIBITED.

No person shall, by building or paving, impede the natural flow of water.

ADOPTION OF STATE CODES

§ 150.15 ADOPTION OF KENTUCKY BUILDING CODE; STANDARDS OF SAFETY.

The Kentucky Building Code, as contained in Chapter 7, Title 815 of the Kentucky Administrative Regulations; the Kentucky Plumbing Code, as contained in Chapter 20, Title 815 of the Kentucky Administrative Regulations; the Kentucky Standards of Safety, as contained in Chapter 10, Title 815 of the Kentucky Administrative Regulations, together with any amendments, are hereby adopted by reference as if fully set forth in this code of ordinances. Copies of the above codes and any amendments thereto shall be placed on file in the office of the City Clerk or City Clerk/Treasurer where they shall be available for public inspection by appointment.

§ 150.16 ENFORCEMENT.

(A) The County Building Inspector is designated as the official who shall enforce the provisions of the Kentucky Building Code, adopted in § 150.01(A).

(B) The Kentucky Standards of Safety, adopted in § 150.01(A), shall be enforced by the Chief and other officers and employees of the Camp Taylor Fire District.

§ 150.99 PENALTY.

(A) Any person who violates any provision of the state codes adopted in § 150.15 shall be subject to the following penalties:

(1) Violators of the State Building Code shall, upon conviction, be subject to a fine of not less than \$10 nor more than \$1000 for each offense. (KRS 198B.990(1))

(2) Violators of the State Standards of Safety shall, upon conviction, be subject to a fine of not less than \$25 nor more than \$1000, imprisonment for not more than 60 days, or both, for each offense. (KRS 227.990(1))

(3) Violators of the State Plumbing Code shall, upon conviction, be subject to a fine of not less than \$10 nor more than \$100, imprisonment for not more than 90 days, or both, for each offense. (KRS 318.990).

(B) Any person who violates any provision of this chapter for which no penalty is otherwise specifically provided shall be fined not more than \$500.
