Special Meeting Called to Order – Chairman Lee Harrison called the special meeting to order. The meeting was opened with the Pledge of Allegiance and the Lord’s Prayer.

The special meeting was advertised in the Post and Courier under “Legal Notices” on Wednesday, July 10, 2019 and posted on the front door 24 hours prior to the meeting.

A motion was made by Commissioner Charlie Fox and seconded by Vice-chairman Ronald Muckenfuss to go into Executive Session for discussion of compensation for Chief and Assistant Chief and for discussion of the continued promotion of conditionally promoted Lieutenants and Captains. Motion passed.

EXECUTIVE SESSION - Discussion of compensation for Chief and Assistant Chief and Discussion of the continued promotion of conditionally promoted Lieutenants and Captains.

Out of Executive Session – Into Regular Session – No action was taken in Executive Session. There was a discussion of compensation for Chief and Assistant Chief and discussion of the continued promotion of conditionally promoted Lieutenants and Captains.

A motion was made by Commissioner Arnold Collins and seconded by Vice-chairman Ronald Muckenfuss that all conditionally promoted Lieutenants and Captains salaries remain frozen until they have certifications to pass required courses to get the promotion. Commissioner Charlie Fox asked for a roll call vote. A motion was made by Vice-chairman Ronald Muckenfuss and seconded by Commissioner Arnold Collins to give the Chief a \$4,000 pay raise and Assistant Chief a \$3,000 pay raise. Roll call vote was: Commissioner Arnold Collins voted in favor of the motion, Vice-chairman Ronald Muckenfuss voted in favor of the motion, Commissioner Larry Gerth voted in favor of the motion, Commissioner Charlie Fox voted not in favor of the motion, Commissioner Irvin Gadsden voted in favor of the motion and Chairman Lee Harrison voted in favor of the motion. Motion passed with a majority vote. Commissioner Charlie Fox voted not in favor of the motion until we move forward to evaluations.

A motion was made by Commissioner Arnold Collins and seconded by Commissioner Charlie Fox that all salaries are frozen until job descriptions and evaluations are done. Roll call vote was: Commissioner Arnold Collins voted in favor of the motion, Vice-chairman Ronald Muckenfuss voted in favor of the motion, Chairman Lee Harrison voted in favor of the motion, Commissioner Larry Gerth voted in favor of the motion, Commissioner Charlie Fox voted in favor of the motion, and Commissioner Irvin Gadsden voted in favor of the motion. Motion passed.

A motion was made by Commissioner Charlie Fox and seconded by Commissioner Arnold Collins that there will be no promotions until promotional policy and job description for the position that is open is in place. Roll call vote was: Commissioner Arnold Collins voted in favor of the motion, Vice-chairman Ronald Muckenfuss voted in favor of the motion, Chairman Lee Harrison voted in favor of the motion, Commissioner Larry Gerth voted in favor of the motion, Commissioner Charlie Fox voted in favor of the motion, and Commissioner Irvin Gadsden voted in favor of the motion. Motion passed.
