CEU News Alert! In October, 2017, the Iowa Dental Board passed new continuing education requirements for dental professionals. Starting September 1, 2018, dentists, dental hygienists and dental assistants are now required to have a minimum of one CEU for infection control and one CEU for jurisprudence each biennium. Dental assistants are still required to have two CEU's of radiology update. CPR with the required hands on component and the mandatory reporter requirements are unchanged. (IAC 650-25.4 153)

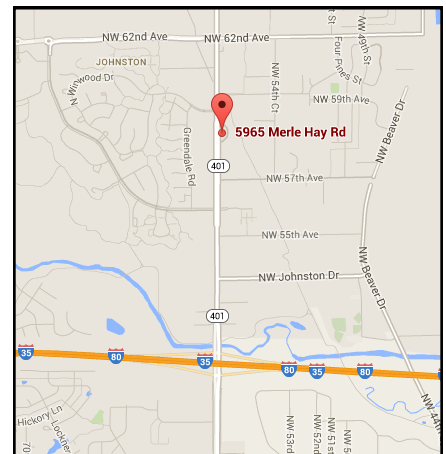
Registration: Pre-registration is required for each participant. Included is an individual registration form and an office/group registration form to be used if there is more than one registrant included with the same payment source/check.
