CEU News Alert! In October, 2017, the lowa Dental Board passed new continuing education requirements for dental professionals. Starting September 1, 2018, dentists, dental hygienists and dental assistants are now required to have a minimum of one CEU for infection control and one CEU for jurisprudence each biennium. Dental assistants and hygienists must have the courses for their 2019 renewal. Dentists are required to have the courses for their 2020 renewal. Dental assistants are still required to have two CEU's of radiology update. CPR with the required hands on component and the mandatory reporter requirements are unchanged. (IAC 650-25.4 153)

Objectives: At the completion of this course, participants should be able to:

• Understand theory of radiation and how it relates to the production of x-ray beam • Understand parts of the x-ray machine • Understand uses of radiography and types of films used in dentistry • Review ways to protect patient and operator during exposure • Understands purpose/requirements of quality assurance plan • Review paralleling and bisecting techniques • Understands purpose, techniques and principles for exposing bitewing, periapical and full mouth series. • Review radiographic errors and understands ways to correct the error


