



PLAYER WAIVER & RELEASE FORM

Every player must complete the waiver & release of liability form and give it to a Mission Possible 360 official before he or she can play. If a player fails to submit their player & release form, the player may not participate.

ACTIVITY WAIVER & RELEASE OF LIABILITY. PLEASE READ CAREFULLY THIS AFFECTS YOUR LEGAL RIGHTS.

In exchange for the participation in the activity of the Mission Possible 360 3-on-3 Basketball Tournament in November 2018 and/or the use of property and basketball facilities of the Inner City Basketball Development, I agree for myself and (if applicable) for the members of my family, heirs, and assigns, to the following:

1. I agree to observe and obey all posted rules and warning, and further agree to follow any oral instructions or directions given by Mission Possible 360, Inc. ("MP360") and Inner City Development officials, officers, employees, volunteers, board members, representatives and agents.
2. I agree that I have read and agree to abide by the rules and policies set for the tournament and use of Inner City Development basketball courts and the integrity of MP360.
3. I recognize that there are certain and inherent risks associated with the above described activity, and I assume full risk of personal injury, or loss of property, on behalf of myself and (if applicable) my family members, heirs, assigns, executors, and administrators. I further release and discharge MP360 and Inner City Development, and their officials, officers, employees, volunteers, board members, representatives and agents, for injury, loss or damage arising out of my or my family's use or participation in the tournament and presence upon the facilities of MP360 or Inner City Development, whether caused by the acts or omissions if myself, my family MP360 or Inner City Development or other third parties.
4. I hereby waive the right to any claims of personal injury or property loss or damage and I release, save, hold harmless, and indemnify MP360 and Inner City Development, and their officials, officers, employees, volunteers, board members, representatives and agents against all claims, causes of action, damages, judgments, costs, or expenses, including attorney fees, and other litigation costs, which may arise from my or my family's participation in the MP360 tournament and use or presence upon the basketball courts and other facilities of Inner City Development.
5. I agree to pay for all damages to the facilities Inner City Development caused by my or my family's negligent, reckless, or willful actions.
6. Any legal or equitable claim that may arise from participation in the above shall be resolved under Texas Law.
