118th Session of the Central Annual Conference

Conference Minutes Friday, Oct 6, 2017

9:00 AM

Devotion began at 8:45 a.m. with the Reverends Rhonda McIntyre, Mikel James, and Bro. Anthony McClendon. The Reverend McIntyre presented the Bishop. Bishop greeted the Conference at 9:00 a.m.

APPROVAL THE PREVIOUS DAY'S MINUTES

READING OF THE THURSDAY SESSIONS' MINUTES (9:01 A.M. - 9:57 A.M.)

The Reverend Dr. Missiouri McPhee and the Reverend Arthur Davis, Jr. Assistant Conference Secretaries read the minutes of the Thursday Sessions` and Worship services.

Action by the Conference:

The Reverend Patrick Sasnett moved that the Conference adopt the minutes from Thursday per section, seconded by The Reverend Jeffrey Dove – **motion carried**.

Thursday Morning Opening Minutes – (Opening Morning Minutes readings)

It was moved by The Reverend Charles Jackson and properly seconded by The Reverend Joseph Brooks that this portion of the Thursday Minutes be adopted by the Conference with any necessary corrections. Having addressed all unreadiness, the motion carried.

<u>Thursday Morning – (Minutes of the Conference Institute, Ministerial Efficiency Committee Reports, Conference Trustees Report, Christian Stewardship Reports – Sessions from 9:15 – 11:45 am)</u>

It was moved by the Reverend Reginald Johnson and properly seconded by T. Patricia Nelson that these portions of the minutes be adopted by the Conference with any necessary corrections. Having addressed all unreadiness, the motion carried.

<u>Thursday Afternoon Minutes – (Service of Ordination, Superannuation of Preachers, and Holy Communion, Church at Work Sessions 12:03-2:45, 3:30-4:35 pm)</u>

It was moved by the Reverend Lorenzo Laws and properly seconded by the Reverend Robert Simmons that this portion of the minutes be adopted by the Conference with any necessary corrections. Having addressed all unreadiness, the motion carried.

Thursday Evening Minutes - Annual Lay Witness Session (7:00 p.m. - 9:15 p.m.)

It was moved by the Reverend Patrick Sasnett. and properly seconded by The Reverend John Williams that this portion of the minutes be adopted by the Conference with any necessary corrections. Having addressed all unreadiness, the motion carried.

Presentation by the Reverend James C. Givens (10:01 a.m. – 10:15 a.m.) Eleventh Episcopal District Director of Christian Education

Bishop Richardson presented the Reverend James C. Givens to the Conference at approximately 10:01 a.m. The Reverend Givens brought greetings to the Conference and provide an overview of the 2017 Christian Education Youth & Leadership Congress (CEYLC). The Reverend Givens made mention of the three new initiatives undertaken by the Board of Christian Education to include: (1) The Bishop Edward Waters Scholarship; (2) The Scouting Ministry; and (3) The Post-Congress.

The Reverend Givens paused to thank the Reverend Jeffrey Dove and the Sons of Allen for their work with the Scouts prior to his (the Rev. Givens) appointment as Episcopal Director of Christian Education. The Reverend Givens informed the Conference that Mr. Herman Floyd (East Conference) was appointed as the Eleventh Episcopal District for the Boys Scouts. The Reverend Givens is requesting that the Presiding Elders of the Conference appoint a Girl Scout and Boy Scout Director for their respective districts. The Reverend Givens is requesting that this be done by the Bishop's Planning Meeting in November 2017. The Reverend Givens also gave a brief overview of the Partnership between the Central Florida Council of the Boy Scouts of America and the Citrus Council of the Girl Scouts of the U.S.A. that was manifested at the 2017 Congress with a Merit Badge University and G.I.R.L. Power Initiative. The Reverend Givens also made mention that the Ninth Judicial Circuit Court Senior Judge, the Honorable John Adams, who was attending the Florida Circuit Court Judges Convention, expressed appreciation for the effort the AME Church is making with the scouts and vowed to support the next year's scouting programming at the Christian Education Youth & Leadership Congress (CEYLC)

The Reverend Givens then presented Presiding Elder Henry L. Postell, II with a certificate to commemorate the fact that the North Orlando District registered the most delegates to the 2017 CEYLC.

The Bishop's Moment

Bishop Richardson made comment that young Jacob Cuthbert, III (Star Ranked Scout, and member of Saint Mark, Orlando) was responsible for the inception of the Scouting Program at the CEYLC. Bishop Richardson also made mention that Jacob was in attendance at the Boy Scouts of America 2017 National Jamboree when #45 addressed the audience. Jacob expressed his disappointment with #45's address and his appreciation for his church and scouting training. Bishop stated that Jacob brought scouting to the Central Conference and he is doing a fine job in his scouting ministry. Bishop expressed how proud he and the Supervisor are of young Jacob.

Bishop Richardson went on to express that part of Supervisor Richardson's community service while they lived in Tallahassee was as a Girl Scout Leader. Bishop expressed that he and the Supervisor are very much proponents of scouting ministries (Girl Scouts & Boy Scouts) in the AME Church. Bishop stated that when he occupied the pastorate at Bethel, Tallahassee, he appointed leaders who were interested in mobilizing the scouting ministry. Bishop Richardson is encouraging every church in the Conference to engage in scouting ministry.

Stretch Break

21st Century Church School

It was moved by the Reverend Jeffrey Dove and properly seconded by the Reverend John D. Williams, Sr. to adopt the report of the 21st Century Church School with any necessary adjustments. The motion carried.

Bishop's Moment

Bishop Richardson made mention that all reports will be posted online at www.centralconference11thdistrict.org. Bishop Richardson also announced that the Bishop Richard Allen stamps are now out of print. They may be available online, but they can no longer be found in the post office. Any remaining stamps will be destroyed.

State of the Church (10:25 a.m)

It was moved by the Reverend Robert Simmons, Sr. and properly seconded by the Reverends Joseph Brooks and Gloria House to adopt the report of the State of the Church with any necessary adjustments. The motion carried.

Bishop's Moment

Bishop Richardson stated that the State of the Church is active and relevant to community life. Bishop suggested that future reports should include a comparative analysis of the statistical information from the previous year. Bishop stated that based on the State of the Church report, no one should be embarrassed to be AME. The report puts a smiley face on the work and ministry of the AME Church in the Central Conference.

Committee on Living Well – Life in Balance

It was moved by the Reverend Gerard A. Moss, Sr. and properly seconded by the Reverend Ruth D. Diehl to adopt the report of the Committee on Living Well – Life in Balance with any necessary adjustments. The motion carried.

Comments

- The Reverend Jeffrey Dove stated that the Sons of Allen have adopted the prostate cancer cause as an initiative.
- Bishop encouraged the Committee to do the research as it pertains to "Alternative Medicine."
- Bishop further indicated that "prayer" and "meditation" are NOT "alternative medicine," they are necessary.

Christian Education (11:09 a.m. – 11:20 a.m.)

It was moved by the Reverend Jeffrey Dove and properly seconded by the Reverend Lamarda Brooks to adopt the Christian Education report with any necessary adjustments. After a spirited discussion, the motion carried.

Comments

- The Ruth Diehl expressed concern that the recommendations being offered places an undue burden on smaller churches. She suggested that churches cluster to share resources.
- Bishop Richardson stated that when he was elected in 1996 and assigned to West African, there were five countries assigned to the 15th Episcopal District. When he arrived on the Ivory Coast, they had 11-14 churches. As a Bishop, he had to do everything for that Conference as he would do for the other Conferences with 70 churches. The same amount of time and energies need to be given smaller churches as given to larger churches. Clustering with churches enhances the fellowship.
- Pursuant to Bishop Richardson, Christian Education for the Bishop is the "whole thing" of the Church. Everything that is done in the Church is Christian Education From the kneeling in the pulpit to the reading of the scriptures.
- The Reverend James Givens announced the Christian Education Training in Jacksonville in January 2018. The Reverend Givens is requesting that all local churches and Presiding Elders consider sponsoring their CEDs and Church School Superintendents.

Women in Ministry Report

The Women in Ministry Report was read by the Reverend Kimberly Stockton, Conference President. She along with the Reverend Dr. Rhella Murdaugh presented Bishop and Supervisor Richardson a gift (original drawing sketch of their official photograph) from the Conference Women in Ministry.

It was moved by the Reverend Lovisa Moore and properly seconded by the Reverend Jiles J. Smith that the Women in Ministry Report be adopted with any necessary adjustments. After a brief discussion, the motion carried.

Bishop's Comments

Pursuant Bishop Richardson, the Central Conference has the largest number of women in ministry including the Licentiates.

The Ministry to Young Adults Report was read by the Reverend Mikel J. James. It was moved by the Reverend Willie N. Barnes, Jr. and properly seconded by the Reverend

Joseph L. Brooks that the Ministry to Young Adults Report be adopted with any necessary adjustments. After a brief discussion, the motion carried.

Bishop's Comments

Bishop Richardson stated that the report should include what we are doing and what we are not doing.

Evangelism & Church Growth Report (11:58 a.m. – 12:00 p.m.)

The Evangelism & Church Growth Report was read by the Reverend Odell Watson. It was moved by the Reverend Lorenzo Laws and properly seconded by the Reverend Jeffrey Dove to adopt the Evangelism & Church Growth report with any necessary adjustments. The motion carried.

Christian Stewardship (12:01 p.m. - 12:30 p.m.)

The Christian Stewardship Report was read by the Reverend Patrick J. Sasnett. It was moved by the Reverend Jeffrey Dove and properly seconded by the Reverend Charles Robert Jackson to adopt the Christian Stewardship report with any necessary adjustments. After a spirited discussion, the motion carried.

Discussion

The Reverend Terence R. Gray, I commented that there can be no talk about stewardship without considering tentmaking. Churches are not going to show any progress if over half of the resources are going to pastor's salaries. Pastors have to pace and take the time to move the church. The Reverend Gray charged the committee with amending their report to include that the practice of electronic giving is necessary. The millennials are not giving cash. They don't carry cash. They carry cards.

Bishop Richardson thanked the Reverend Gray for opening the door to a larger conversation. Bishop Richardson stated that pastors and members would have to work together to negotiate how far they want the church to grow. Some pastors receive as much as 80% of the churches' income. The church will not grow beyond its pastor. Bishop said that there is no shame in a pastor having secular employment in addition to the pastorate. Throughout the vast majority of his pastorate, Bishop indicated that he had a job. He worked at the funeral home and did substitute teaching. He also taught Religion as an adjunct professor at FAMU. Bishop Richardson received the report as loaded with principles of stewardship that applies to both sides.

The Ministers, Pastors, Presiding Elders and Bishop Adam J. Richardson dressed in black robes marched grandly in singing "God of Grace and God of Glory (#62 AMECH)." The Central Conference Choir led us in extraordinary musical grandeur with Presiding Elder Hartford Lee serving as Worship Leader.

Bishop Richardson preached the closing sermon entitled "In the Beginning God Created the Heaven and Earth," one of his finest exegetical and most powerful homiletical proclamations. He began the sermon by speaking in the Hebraic language (bərē'šît bārā' 'ĕlōhîm 'ēt haššāmáyim wə'ēt hā'áreṣ) : דָּרֵאשֶׁית בְּּרֵא אֱלֹהֶים אֵת הַשְּׁמֵיִם וְאֵת הָאֶרֶץ: The text was taken from Genesis 1. Along with the text, Bishop Richardson expounded on the Affirmation of Faith and the Baptismal Creed. These are universal, theological, Christological, ecclesiological, and eschatological. He proclaimed that God vastness reaches beyond anthropological study and genderism of mankind. Only Jesus, in His being, deserves the title of "Awesome." The sermon reached to the highest echelon of scholarship with power, yet with the polyvalence to reach the understanding of every listener.
