Re: Open Records Request

District Attorney Daniel Hooge and Sheriff Kerry Lee,

Under the Nevada Open Records Act § 239 et seq., I am requesting an opportunity to obtain copies of public records that the Lincoln County District Attorney's Office and the Lincoln County Sheriff's office has in their possession. I hereby request the following records:

1. All records that is in regards and pertaining to the Area 51 Base;
2. All written communication in which the Lincoln County Sheriff's Office and the Lincoln County District Attorney's Office has, including but not limited to emails and letters, that were sent to officials and staff members of Lincoln County, Nevada by officials and staff members of the Area 51 Base;
3. All written communication in which the Lincoln County Sheriff's Office and the Lincoln County District Attorney's Office has, including but not limited to emails and letters, that were sent by officials and staff members of Lincoln County, Nevada to officials and staff members of the Area 51 Base;
4. All written communication in which the Lincoln County Sheriff's Office and the Lincoln County District Attorney's Office has, including but not limited to emails and letters, that were sent to and by the White House, federal governmental bodies, and intelligence agencies to and from officials with Lincoln County, in regards and pertaining to extraterrestrials, extraterrestrial life, unidentified flying objects and the Area 51 Base;
5. All written communication, including but not limited to emails and letters, to and from officials and staff members of the Lincoln County Sheriff's Office and the Lincoln County District Attorney's Office and officials with Lincoln County, Nevada to each other regarding and pertaining to extraterrestrials, extraterrestrial life, unidentified flying objects and the Area 51 Base;


6. All written contracts and agreements between the Lincoln County Sheriff's Office, the Lincoln County District Attorney's Office and Lincoln County, Nevada to and with officials of the federal government regarding and pertaining to the Area 51 Base.

I would like to request a waiver of all fees in that the disclosure of the requested information is in the public interest and will contribute significantly to the public's understanding of the way in which the government operates, information that officials with Lincoln County, Nevada have as t Area 51, communication between Lincoln County, Nevada and Area 51 officials, extraterrestrials, extraterrestrial life, unidentified flying objects, and et cetera. Please also note that the information that I am requesting has educational value, informative value, or the potential for the contribution for public understanding and will contribute to the public understanding of as to the operations of the government.

If you choose to deny this request, please provide a written explanation for the denial including a reference to the specific statutory exemption(s) upon which you rely. Please then provide all segregable portions of otherwise exempt material. I would note that violation of the open records law may result in the award of court costs and attorney fees. See Nev. Rev. Stat. Sec. 239.011. I would also note that the intentional concealment of a public record is a category C felony, punishable by up to 5 years in prison, a fine of up to \$10,000, or both. See Sec. 239.320.

As provided by the open records law, I will expect your response with five (5) business days. See Nev. Rev. Stat. Sec. 239.0107. However if access to the records I am requesting will take longer than this amount of time, please contact me with information about when I might expect copies or the ability to inspect the requested records.
