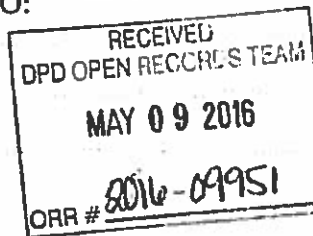

Re: Public records request: Dallas Police Department partnership with church

To Whom It May Concern:

I am writing on behalf of the Freedom From Religion Foundation (FFRF) to obtain public records. FFRF is a national nonprofit organization with more than 23,500 members across the country, including over 900 members in Texas. Our purpose is to protect the constitutional principle of separation between religion and government.

It is our understanding that the Dallas Police Department has partnered with First Baptist Dallas. The partnership was announced on April 17, during the "Back the Blue" church event, in which Dallas Police Chief David Brown spoke. We understand that the partnership includes First Baptist Dallas providing counseling services to police department officers, weekly bible classes for officers, and money to be used in a "Chief's Award Fund" that the church will give to Chief Brown to "honor those men and women in his department worthy of special recognition."<sup>1</sup>

We write to ensure that the Dallas Police Department is not using its resources to endorse First Baptist Dallas, or to entangle itself in the church or religion. Such religious endorsement by a government entity would violate the Establishment Clause of the First Amendment.

In order to gain a better understanding about the nature of the police department's ongoing involvement with this church and its involvement in the Back the Blue event, we are seeking records that clarify the arrangement. Pursuant to the Texas Public Information Act (Tex. Gov't Code Ann. §§ 552.001– 552.353), I request a copy of all records related to the Dallas Police Department's involvement with First Baptist Dallas or the Back the Blue event, including the following records, from January 2015 to present:

- 2) All communications (including email and commonly posted notices) from any Dallas Police Department representative (including Chief Brown) to Dallas Police Department officers regarding: a) the Back to Blue event, b) First Baptist Dallas, or c) the services that First Baptist Dallas is now providing to the police department (including counseling services, bible classes, worship services, and the Chief's Award Fund);

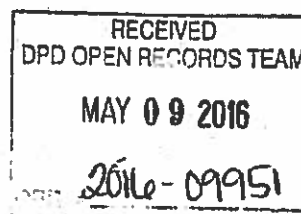

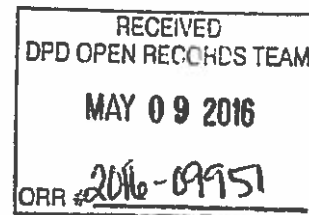

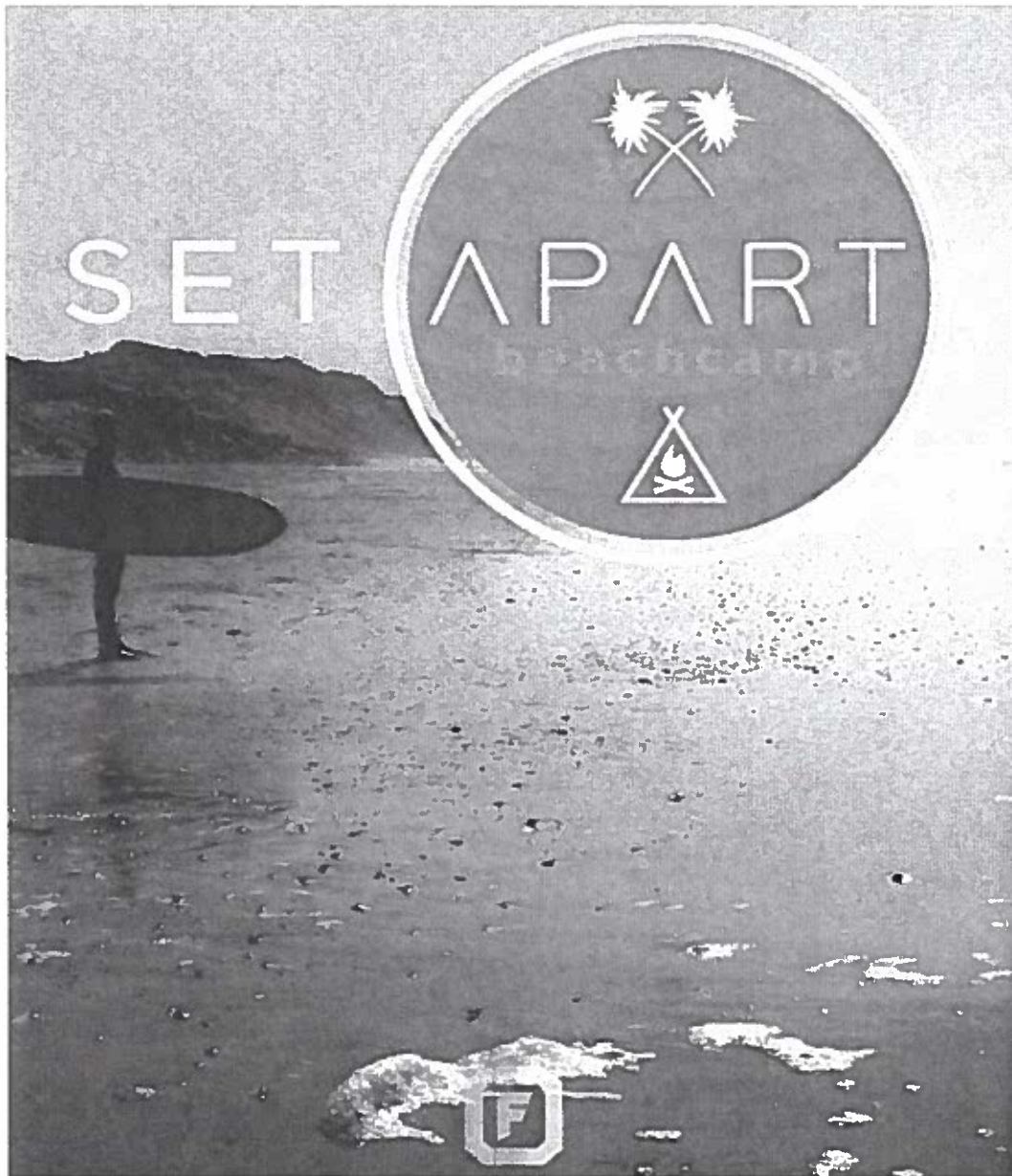

Please check-in **Saturday, June 11<sup>th</sup> @ 9pm** in the Wicker Gym on the 4th floor of the Horner Family Center of First Baptist Dallas. We will load the buses and depart from First Dallas ASAP.

### **Arrival back to First Dallas:**

We will return to First Dallas on **Thursday, June 16 @ approximately 10pm**, in the evening. Park in the Horner Parking Garage and meet your student at the Jeffress Fountain Plaza. Please don't come to the church **until you receive a call from your student** letting you know when we plan to arrive. We don't want you waiting if we are late for any reason.

### **Contacting your Student during Beach Camp:**

Cell phones are not permitted during the day at Beach Camp; this will help remove a significant distraction and help insure that your student has the maximum amount of interaction with both God and others.

**Have the attitude: no news is good news.** In the event of an emergency and you have tried contacting Ryan, Andrew and Julia but cannot get them on the phone (leave voicemails), please call the Security Desk of First Baptist Dallas at (214-969-2408) and they will help you get in touch with Ryan, Andrew or Julia.

**Do Not Bring:** energy drinks, alcoholic beverages, tobacco products, firearms, knives, drugs, fireworks, electronic equipment (*video games, game systems, iPods, laptops, iPads*), balloons (or launchers), inappropriate clothing, "short" shorts, bikinis, super tight clothing, skimpy tanks, tube tops, halter tops, or any revealing clothing.

**GIRLS must wear one-piece swimsuits (no tankinis)**



## **Beach Camp 2016 RULES**

- ❖ Obey Adult Leaders without question or hesitation. They are in charge of you for the week of Beach Camp.
- ❖ Your Leader must know where you are at all times. It is your responsibility to tell your Leader where you will be at all times.
- ❖ Absolutely no one is allowed out of their room after curfew.
- ❖ Students are not allowed onto the balconies without the supervision of their counselor. In addition, absolutely nothing is to be dropped or thrown from the condominium balconies or upper level areas.
- ❖ Profanity or cursing is not allowed.
- ❖ Do not associate with anyone who is not a part of our Beach Camp group or Student Life Camp.
- ❖ Swim only when and where lifeguards are on duty.
- ❖ Keep your condominium clean. No raids or rough play. You are financially responsible for any damage to property, especially to a condominium or bus.
- ❖ Quiet Time begins at 10:00pm each evening. Please be courteous to other guests staying at the condominiums by observing this time.
- ❖ Do not push, pull, or throw anyone into a pool.
- ❖ Do not feed seagulls...period.
- ❖ You are to be on time for everything.
- ❖ Be positive. Cut downs, criticism, and negative comments are not allowed.
- ❖ Only one piece swimsuits are allowed. Please note: students wearing tankinis or similar 2 piece swimsuits will be asked to wear a t-shirt over their suits (an ugly, long sleeve t-shirt).
- ❖ Wear shoes at all times, even when walking on the beach.
- ❖ Be extremely cautious around traffic.
- ❖ Guys may not go into girls' condos and girls may not go into guys' condos unless your Adult Leader is present, and it is a planned and organized activity.
- ❖ You are not allowed to bring or purchase any of the following: energy drinks, alcoholic beverages, tobacco products, firearms, knives, drugs, fireworks, radios, CD/DVD/MP3 players, televisions, portable video games, balloons, balloon launchers, or inappropriate T-shirts. While at camp, you may not participate in any of the following: temporary or permanent tattooing, haircuts, or ear/body piercing.
- ❖ During your free time, you are not to be in any condo including your own, for more than 10 minutes, unless your Adult leader is present with you.
- ❖ Any student who sets off a fire alarm as a prank will be turned over to the police department. Upon release, the student will be sent home immediately.
- ❖ Students who break the rules will lose free time and could be sent home at their own expense.
