His Excellency Mr. Kim Jong-un,

I would like to say that I am extremely appreciative of the peace talks between the Democratic People's Republic of Korea and the United States being successful. I was extremely confident that peace talks would occur between the Democratic People's Republic of Korea and the United States for some time now and that is something that I hoped that both parties would take advantage of. Despite their being evidence of hostility between both countries toward one another, I am glad that both parties put down their hostility towards the other country for the purpose as to ensuring that the peace talks between one another occurred and was successful.

Currently as I am sure that you are aware, there are some concerns from both sides that still do involve security concerns against the other country.¹ It is upon theory and belief that officials with the government of the United States want an immediate denuclearization of the Democratic People's Republic of Korea. It is also upon theory and belief that the government of the Democratic People's Republic of Korea is skeptical of officials with the government of the United States for pushing for an immediate denuclearization of the Democratic People's Republic of Korea.² There are also concerns by some political figures that the past peace talk summit will not resolve the security "concern" conflict between the two countries and that any further peace talk meeting should not occur.³ As you probably already know by now, I am in complete and I am in total opposition to any attempt to cancel peace talks between one country to the other. I believe that the best way for two countries to resolve hostility or

any conflict is by having some type of informal or formal resolution, by and through peace talks occurring between the parties in a neutral setting.⁴

As with regard to improving diplomatic relations between the Democratic People's Republic of Korea and Japan is concerned, it appears as if the government of the Democratic People's Republic of Korea is attempting to form a task force as to dealing with diplomatic relations with Japan.⁵ I believe that this newly formed task force is an extremely intelligent decision to make and I believe that this newly formed task force needs to serve a purpose as to improving diplomatic relations between the Democratic People's Republic of Korea and Japan. I believe that hostility that both the Democratic People's Republic of Korea and Japan have against one another needs to be peacefully resolved and I am confident that this is possible. I am confident that both the Democratic People's Republic of Korea and Japan will be able to successfully enter into peace talks between one another in the future. These future peace talks will be and should be considered to be steps as to attempting to resolve any conflicts that both countries have between one another. Therefore, I am hoping that the newly formed task force will help serve that purpose and I am confident that this is possible even if the final establishment of a treaty may take time.

The last situation that is occurring in our world that I would like to respectfully bring to your attention, as I have also done so with various governments of different countries throughout our world, does involve the situation in the Republic of the Union of Myanmar. Previously and currently in the Republic of the Union of Myanmar, there is a crisis occurring against the Rohingya people that live in areas that are located inside of the Republic of the Union of Myanmar. Just so that it is understood, the Rohingya people have been long mistreated by officials with the government of the Republic of the Union of Myanmar for some time now.⁶ The United Nations in 2013 stated that the Rohingya people are some of the most persecuted people in the world. There appears to be evidence that would make a reasonable person conclude that the government of the Republic of the Union of Myanmar has mostly been and has remained deliberately indifferent to addressing atrocities that have occurred against the Rohingya people. As a response to atrocities that have been committed against the Rohingya people, the government of the Republic of the Union of Myanmar has attempted to ban the name Rohingya, they have used their military officials to carry out attacks in the areas where the Rohingya people occupy, and they have refused, in practically all cases, to investigate the conduct of their officials against the Rohingya people. All of those actions by officials with the government of the Republic of the Union

of Myanmar would absolutely make a reasonable person harbor doubts about the willingness of officials with the government of the Republic of the Union of Myanmar, to have the ability to investigate the actions and the conduct of their officials and whether they are able to actively investigate the atrocities that have occurred against the Rohingya people. It is to my knowledge and understanding that the International Criminal Court is investigating the atrocities that have occurred and that are occurring.


The atrocities that have been committed against the Rohingya people are very concerning, disappointing and are disgusting. I believe that countries that are a part of the international community need to all work to ensure that the Rohingya people are protected from harm and that their inalienable rights are protected. I believe that this will be able to be done by countries that are a part of the international community considering the establishment of a two-state solution in response to the Rohingya crisis in the Republic of the Union of Myanmar and by putting limitations on their trade practices in the Republic of the Union of Myanmar. As with regard to a two-state solution idea that I have come up with to address this crisis situation, I believe, and I am hoping that a two-state solution occurs, by making all of the land that the Rohingya people occupy in the Republic of the Union of Myanmar, their own land and by allowing and giving the Rohingya people the right to establish and to form their own working government, as well as their own police, security forces and other governmental bodies that a government of a country would traditionally have, if and when necessary. I am hoping that governments of countries that are a part of the international community and that international organizations will be involved in helping ensure that this is a reality, if and when necessary. I do not believe that the government of the Republic of the Union of Myanmar would be in opposition that something like that occurring. I have that view because in the past, officials with the government of the Republic of the Union of Myanmar have tried to strip the Rohingya people of their own citizenship. So based on their past conduct, one could come to the conclusion that officials with the government of the Republic of the Union of Myanmar would approve a two-state solution idea as the best way to address the Rohingya crisis situation.

I believe that once a two-state solution is established for the Rohingya people, I believe that there would be a lot of benefits with a two-state solution occurring. If and once a two-state solution is established in this regard, I do not believe that the Rohingya people would have to worry about atrocities being committed against them by their own government, if they were allowed to rule themselves, in an area that they occupy, from the Republic of the Union of Myanmar. I believe that humanitarian assistance that would be intended to go to the Rohingya people, would actually go to the Rohingya people, once a two-state solution was established. I even believe that the total number of Rohingya individuals massively immigrating from the Republic of the Union of Myanmar into other countries would decrease, due to the Rohingya people now being able to live in their own area in which will and would be stable.

While it may take some time for the peaceful establishment of a two-state solution of the area of land that the Rohingya people live in, if necessary, I believe for now that a good way to help ensure that the Rohingya crisis situation is resolved, is by countries that are a part of the international community, as well as the major and the minor trading partners of the Republic of the Union of Myanmar, to start reforming their trading practices in the Republic of the Union of Myanmar, to

“everything but an arms scheme.”⁷ As far as the trading practices that involves the Democratic People’s Republic of Korea and Myanmar is concerned, it has been asserted that, according to monitors of the United Nations, that the government of the Republic of the Union of Myanmar has received arms and ballistic missile systems from the Democratic People’s Republic of Korea. While this may or even may not be true, I am hoping that if it is true, that the government of the Democratic People’s Republic of Korea would limit its arms sales to the government of the Republic of the Union of Myanmar to “everything but an arms scheme.” I believe that doing so will help ensure that the Rohingya people are taken care of and that they will not be subjected to violations of international law, in which the International Criminal Court is currently investigating. But even at the very least, I am hoping that you will have talks with officials of the government of the Republic of the Union of Myanmar, as an attempt to form some type of plan to address the Rohingya situation crisis because that crisis absolutely needs to be resolved in the best way and as soon as possible without politics.

In conclusion, I would like to thank you for turning your attention to this communication, my past communication to you, and I would sincerely hope that the government of the Democratic People’s Republic of Korea will continue peace talks with officials with the government of the United States and that this will also be done with officials with the government of Japan. A future peace talk summit between the Democratic People’s Republic of Korea, Japan and even the European Union is something that I am looking forward to and I am hoping that you will help ensure that this will occur.⁸ I am also hoping that the government of the Democratic People’s Republic of Korea will address the situation in the Republic of the Union of Myanmar, as it pertains to the Rohingya people, with officials of the government of the Republic of the Union of Myanmar, for the purpose as to helping address that atrocity situation and finding a solution to address that extremely concerning crisis situation.
