Dear Friends of O.C.I.M.A.,

As 2014 enters its final month, our thoughts are with you as we reflect on the advances made during this past year and OCIMA's challenges ahead.

If you are like me, you subconsciously track passing years by major events that impact your life. Certainly, an example for me has been this year's 5-year anniversary of Father Nick's passing and the fallout of his loss. Those of us within OCIMA think back to that time and can't help but remember the angst we felt looking ahead and wondering if the organization could continue operating in the same direction without his leadership. Over the next few years it became apparent he had established a network of support that comprehended the needs of the people he and his organization had touched and were aware of the challenges ahead.

Clearly the imprint of his legacy remains indelible upon all of us including our contributors who continue to support our efforts in Guatemala and Ecuador. The need for this support is no longer in response to Father Nick's personal requests, but rather those created by his accomplishments. Therefore, OCIMA's challenge in the near future will be to achieve a relative growth in our donations that will allow us to take full advantage of these more recent opportunities such as the Nursing School at Santa Elena. This project was extremely important to Father Nick and proved to be his final chosen project. Not only has the school gone from concept to reality, but has recently celebrated its first graduate in November. Father Nick strived to eliminate malnutrition first and foremost but had strong ambition for education, and what it can achieve, as a close second.

Another recent example is in close proximity to the Nursing School and when completed will be integral to the Clinic. The Surgical Facility, mentioned in our last letter, has officially gone from paper to concrete, to bricks and mortar and is providing some revealing photographs of its growth. Our challenge will now re-focus on being able to equip this facility in a way so as to provide the proper medical equipment that will meet the needs of the patients and the talent of the doctors.

This year's OCIMA Raffle, which has become our primary fund raising event, was held and again produced adequate proceeds thereby allowing us to fund another food packing event should we desire. By generating sufficient funding through its raffle activity, OCIMA gains additional flexibility for targeted support in other projects.

However, despite available funding, the Board of Directors continues to be in unanimous agreement that no further food packing activity will take place until all final shipping and receiving obstacles, such as those encountered with our last shipment to Guatemala, are eliminated. As a result, solving this issue continues to be a crucial goal for us in 2015. Nevertheless, we are pleased to report that the food shipment that we packed in October 2012 finally passed through Customs and arrived in Santa Elena on July 12, 2014 - 17 months after it left Miami, Florida! From all reports, the food was still intact and distributed immediately after receipt. Plans are being made to investigate a number of

Sister Josefina loved to have a good time, but she was "no-nonsense" when it came to business. We lost a great friend and hard worker.

Please consider what all of us have in our lives compared to the poor, disadvantaged people in Guatemala and Ecuador. Most importantly, consider all the projects we have completed thanks to your donations in the past. I wish all of you could experience what many of us in OCIMA have experienced in person. It all becomes very personal to everyone that makes the trip to Guatemala. Unfortunately, the desperate needs of these people, although finite, are not static. They are growing. Please help OCIMA write some stories during 2015, through your generosity. Let us share them with you next year.
