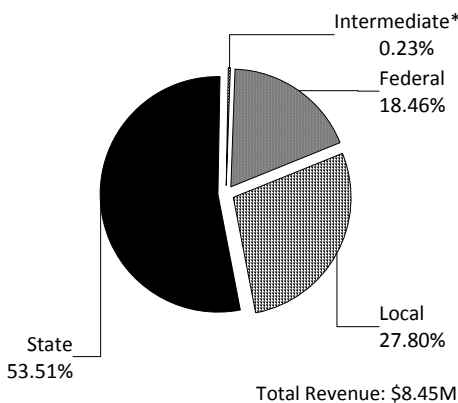

Revenue Sources



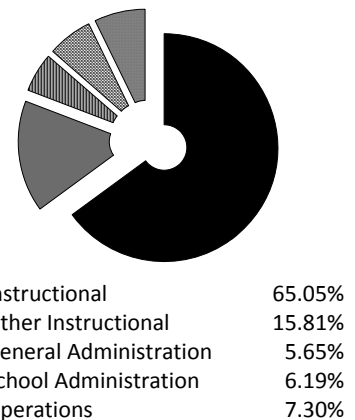
