GUIDELINES AND RULES OF CONDUCT:

1. All Camping assignments will be handled by Festival staff.
2. Because of limited space, each camper will be required to stay within their designated space.
3. Only ONE automobile (including towing vehicle) may be parked in, or at, a camp site.
4. Campers will be allowed to drop off trailers starting on Thursday, July 6, 2017. All trailers/campers will need to be removed from the property no later than 12:00 p.m. on Monday, July 10, 2017.
5. All camping sites are dry, and restrooms are provided on site.
6. Persons under 18 years of age **MUST** have an adult chaperone.
7. Fire lanes must be kept open. Any vehicles in violation will be towed at the owner's expense.
8. Obscene and discriminatory language, disrespect of festival staff, volunteers, other campers, exhibitors, vendors, etc., will result in immediate dismissal, forfeiture of premiums, and having to leave the grounds.
9. Damage to or destruction of, property belonging to others is strictly prohibited and may result in additional charges and/or immediate dismissal and forfeiture of premiums.
10. Quiet hours 10PM to 7AM

The undersigned agree to hold Plum Crazy Events, and the City of Roslyn and its representatives harmless from any and all loss or damage occasioned to me or my property and to any third person or property by reason of any acts or omissions on part of Plum Crazy Events, and the City of Roslyn and its representatives, while storing personal vehicle(s) or camping unit and/or while camping on public property and will defend and pay the expense of defending any suit which may be commenced against Plum Crazy Events, and the City of Roslyn and its representatives or any third person alleging injury by reason of such acts or omissions and will pay any judgment which may be obtained against Plum Crazy Events, and the City of Roslyn and its representatives, in such suit. I further acknowledge that I have read this statement in its entirety, and understand and agree to the terms of this hold harmless waiver, camping guidelines, and rules of conduct.
