TERMS OF ENROLLMENT

1. Enrollment is only valid upon submission of signed contract by the parent or legal guardian of the child enrolled in addition to acceptance of said contract by the Camp Director. By submitting this completed enrollment form and signing herein, parent or legal guardian agrees to Lawrence Woodmere Academy Summer Day Program's terms of enrollment, and any addenda thereto (the "Agreement").
2. The signator of this Agreement represents that he/she has full authority to do so and understands that by signing this Agreement, he/she and the child shall abide by all of the rules and regulations of Lawrence Woodmere Academy Summer Day Program and shall unconditionally be responsible for payment of all fees.
3. In the event there is a default in the payment of any obligations created by this Agreement, in addition to the sums due pursuant to this Agreement, the undersigned parents or guardians further agree to pay all costs, court costs, filing fees and all other fees including attorneys' fees and/or collection agency fees expended or that may be expended in the enforcement of this Agreement and/or for the collection of any sums due Lawrence Woodmere Academy or Lawrence Woodmere Academy Summer Day Program. It is agreed that the venue of any dispute that may arise to which Lawrence Woodmere Academy Summer Day Program or Lawrence Woodmere Academy, or its agents, is a party shall be in Nassau County, New York.
4. **CAMP TUITION PAYMENTS ARE REFUNDABLE UNTIL APRIL 1, 2019.** Should it be necessary for any reason to withdraw the child, no such withdrawal shall relieve the undersigned from the obligations to pay the tuition for the summer season unless such withdrawal shall be by notice, in writing, and delivered to the Summer Day office on or before April 1, 2019.
5. **THERE ARE NO REFUNDS FOR ABSENCES, CHANGES, WITHDRAWALS OR TERMINATIONS.**
6. A deposit of \$750 per child must accompany this signed Agreement, except as otherwise agreed.
7. Please make checks payable to "Lawrence Woodmere Academy Summer Day".
8. **THERE IS A \$250 NON-REFUNDABLE AND NON-TRANSFERABLE PROCESSING FEE FOR REFUNDS REQUESTED BY MARCH 31, 2019. AFTER APRIL 1, 2019, TUITION IS NON-REFUNDABLE AND NON-TRANSFERABLE AND ANY DEPOSIT OR TUITION ALREADY PAID MAY NOT BE REFUNDED OR APPLIED TO ANOTHER SUMMER DAY CHILD.**
9. **50% OF TUITION IS DUE NO LATER THAN JANUARY 15, 2019. TUITION IS DUE IN FULL NO LATER THAN MARCH 1, 2019 OR UPON SUBMISSION OF ENROLLMENT CONTRACT DATED ON OR AFTER MARCH 1, 2019.** The Summer Day season will run from June 27 to August 20, 2019.
10. **If full payment is not received by MARCH 1, 2019, any discounted tuition will be billed at regular, full-tuition rate.**
11. Tuition includes hot lunch, transportation and accident insurance.
12. Lawrence Woodmere Academy Summer Day Program reserves the unrestricted right, at any time, to terminate a child's enrollment for any reason consistent with the needs of the program as well as the right to dismiss any child whose conduct or influence or whose parents', guardians', family members' or friends' conduct or influence, in the opinion of the Director, is adverse to the best interests of the Program. The undersigned shall not be entitled to a refund for any tuition paid prior to the date of such termination and shall be obligated to pay the balance of any tuition for the season designated herein within 30 days after such termination.
13. **Completed medical forms must be submitted to the camp before a child will be admitted. The Program has the right to reject admission mid-program upon expiration of a child's medical form.**
14. **Your signature herein indicates that you grant permission for your child at Lawrence Woodmere Academy Summer Day Program:**
 - To attend off-campus trips and activities
 - To participate in water-related or water activities when traveling off campus, including those that are not inspected by the New York State Department of Health
 - To obtain, through a physician of its choice, such medical care as is reasonably necessary for the welfare of your child if he or she is injured or becomes ill during the course of program activities whether on campus or off campus
 - To have the option to display any photograph, video or likeness of your child for promotional, web display or in-house photo gallery purposes
 - To give out your address, phone number and/or email to other Lawrence Woodmere Academy Summer Day Program families for the purpose of group lists, parties or play dates
15. This Agreement constitutes the full understanding of the parties hereto and no change, modification or waiver of any of the terms shall be effective unless in writing and signed by both parties.
