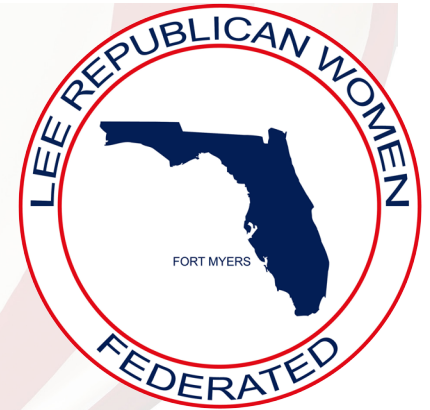

"If My people who are called by My name will humble themselves, and pray and seek My face, and turn from their wicked ways, then I will hear from heaven, and will forgive their sin and heal their land." 2 Chronicles 7:14, NKJV

Many decisions are made at the president's desk, but the major political party to which he or she belongs wields significant power over which domestic and international policies are advanced and what becomes law. Here is a summary of the Democratic and Republican party positions on some of the vital issues facing the country. As Franklin Graham has stated clearly many times, we are not endorsing any candidate or party.

Sanctity of human life

Democratic

Democrats seek to repeal the 1976 Hyde Amendment so that federal funds can be used to pay for abortions. The platform says, "We will continue to stand up to Republican efforts to defund Planned Parenthood health centers." Democrats support ratification of UN efforts that affirm "the reproductive rights of women" globally.

Republican

The GOP asserts the sanctity of human life and affirms, "The unborn child has a fundamental right to life which cannot be infringed." The party supports a Human Life Amendment making clear that the 14th Amendment's protections apply to children before birth, and it salutes states that require informed consent, parental consent, waiting periods and clinic regulation.

Marriage

Democratic

Democrats applaud last year's Supreme Court ruling that "LGBT people—like other Americans—have the right to marry the person they love."

Republican

The GOP platform condemns the Supreme Court's rulings that removed the ability of Congress and the people to define marriage as the union of one man and one woman. The GOP urges the reversal of those decisions, whether through judicial reconsideration or a constitutional amendment.

Religious freedom

Democratic

The Democratic platform says: "We support a progressive vision of religious freedom that respects pluralism and rejects the misuse of religion to discriminate." The party opposes a religious test to bar immigrants or refugees from entering the country.

Republican

Republicans affirm that religious freedom in the Bill of Rights protects the right of the people to practice their faith in their everyday lives. The platform endorses the First Amendment Defense Act, which would protect faith-based institutions and individuals from government discrimination.

Federal judges

Democratic

The platform says: "We will appoint judges who defend the constitutional principles of liberty and equality for all, and will protect a woman's right to safe and legal abortion."

Republican

The GOP platform states: "A critical threat to our country's constitutional order is an activist judiciary that usurps powers properly reserved to the people through other branches of government." The GOP supports the appointment of justices and judges who respect the constitutional limits on their power and respect the authority of the states.

National defense

Democratic

The Democratic platform says that while the military is crucial, decreased military spending is necessary. The party also favors reducing excessive spending on nuclear weapons. The platform notes that it is "proud of the repeal of Don't Ask Don't Tell and the opening of combat positions to women."

Republican

The Republican platform favors building and maintaining a strong military as the path to peace and security. The party seeks to restore the nation's military might and to rebuild troop numbers. The GOP would abandon treaties that benefit adversaries and would modernize the U.S. nuclear arsenal.

Terrorism

Democratic

The Democratic platform uses firm language to say we “must defeat” global terrorism, though noting a preference for “diplomacy and development, to confront global threats and ensure war is a last resort.” The party favors improving international intelligence capabilities to defend against external and homegrown threats.

Republican

The GOP asserts that the Iran deal does not have treaty status and has only emboldened the regime in Tehran in sponsoring terrorism. The platform says, “We must stand up for our friends, challenge our foes, and destroy ISIS.” It calls for governmental aid to Christian communities under genocidal attack in cities like Erbil.

Human rights

Democratic

The Democratic platform recognizes gay rights as a human right, and party leaders have tied international development funds in poor countries to adherence to the LGBT agenda. According to the platform, “We will continue to stand with LGBT people around the world, including fighting efforts by any nation to infringe on LGBT rights or ignore abuse.”

Republican

The GOP platform states: “To those who stand in the darkness of tyranny, America has always been a beacon of hope, and so it must remain.” The party seeks a radical rethinking of our human rights diplomacy, adopting a “whole of government” approach in which human rights issues are integrated at every appropriate level of our relationships with other nations.

Immigration

Democratic

The party platform denounces Donald Trump's suggested ban on immigrants from countries (mostly Muslim) known to train and equip terrorists.

Republican

Republicans oppose any form of amnesty for those who have entered illegally. The party supports building a border wall and refusing entrance to refugees who cannot be carefully vetted, especially those whose homelands have “been the breeding grounds for terrorism.”

Internet safety and decency

Democratic

The platform supports “a free and open internet at home and abroad.” The party would seek to strengthen cybersecurity while “protecting the privacy and civil liberties of the American people.”

Republican

The platform states: “The internet must not become a safe haven for predators. Pornography, with its harmful effects, especially on children, has become a public health crisis that is destroying the lives of millions.”

Addressing poverty

Democratic

Democrats will “direct more federal resources to lifting up communities that have been left out and left behind.” The party would build more affordable rental housing units and seek to “create good-paying jobs and enhance opportunities by investing in small business, youth employment, and reentry programs for formerly incarcerated people.”

Republican

The GOP says that instead of government handouts that keep people dependent, “We propose ... the dynamic compassion of work requirements in a growing economy, where opportunity takes the place of a hand-out, where true self-esteem can grow from the satisfaction of a job well done.”

Law and order

Democratic

The Democratic platform seeks to abolish the death penalty, “which has proven to be a cruel and unusual form of punishment. It has no place in the United States of America.” The party would reform mandatory minimum sentences, close private prisons, end racial profiling and train officers in de-escalation.

Republican

The GOP decries the creation of new “crimes” by unelected civil servants and political appointees and sees this as federal overreach. The platform emphasizes restorative justice, including guidance by faith-based institutions. It notes that the death penalty is firmly settled by the Fifth Amendment and opposes efforts to erode this right.

Israel and Jerusalem

Democratic

The platform states: “We will always support Israel's right to defend itself, including by retaining its qualitative military edge, and oppose any effort to delegitimize Israel. ... While Jerusalem is a matter for final status negotiations, it should remain the capital of Israel, an undivided city accessible to people of all faiths.”

Republican

Republicans express “unequivocal support for Israel,” pointing out that it is the only Middle Eastern country with freedom of speech and freedom of religion. The GOP recognizes “Jerusalem as the eternal and indivisible capital of the Jewish state.” The party opposes the U.N.'s treatment of Israel as a pariah state.

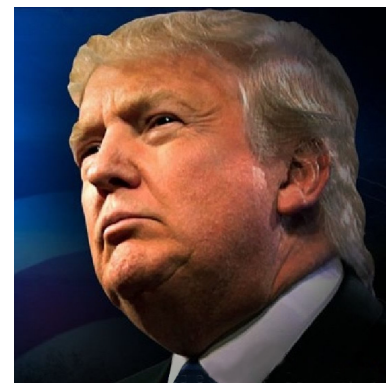

Edith Kermit Carow Roosevelt
1861-1948

Wife of President Theodore Roosevelt

Edith was 16 years old when she became secretly engaged to her childhood friend, Theodore Roosevelt. But an argument a year later ended all plans of marriage. Edith was the middle child of Charles Carow and Gertrude Elizabeth Tyler. Carow's family was in the lucrative import-export business but by the time Edith was six, her father had lost his position and most of his money.

Nevertheless, Edith and her family were close to the Roosevelts. She was educated with the Roosevelt children in New York City and holidays on Oyster Bay. At age four, she watched the Lincoln funeral procession from their home in NYC. Her formal education, which continued until she was 19, included classes in writing, English, history, Latin, Greek, French, zoology, botany, physiology, math, philosophy, penmanship, music, and the theatre. She was also a good sportswoman and adept at riding.

In 1880, Theodore wed 19 year old Alice Hathaway Lee. The couple moved in the same circles as Edith Carow whose closest friends were Anna and Corrine Roosevelt, Theodore's sisters. In 1883, Edith's father died leaving little money. Her maternal grandfather's estate did provide money for the family. However, her mother's income was limited to accessing the interest and not the principle. Because the cost of living was less expensive in London, England, the family moved there.

On Feb. 12, 1884, Alice Lee gave birth to her first child, a daughter, Alice. Two days later, on Valentine's Day, her mother-in-law, who lived with them, came down with typhoid fever and died. Eleven hours later, Alice, died of a kidney ailment undiscovered until after she had given birth. She was 23. Bereft of hope, Ted turned his child over to his sister, Anna, with whom she stayed for two years.

In 1886, Ted and Edith were married in a private Anglican ceremony in London, England. Nine months later, their first child, Theodore, Jr., was born. Edith insisted that little Alice come and live with them and be part of her father's new family. The family quickly grew to include four more children: Kermit, 1889, Ethel, 1891, Archibald, 1894, and Quentin, 1897. The Roosevelts believed it was every citizen's duty to be a parent and those that chose otherwise should be taxed.

Edith was not excited when her husband, then governor of New York in 1889, accepted the nomination as McKinley's Vice-President. Within six months, following the inauguration, and McKinley's assassination, Theodore Roosevelt had become President. And so it happened that Edith, 40, and her brood of six, ages 3 to 15, with an accompanying menagerie of pets, descended on the White House.

Although Theodore Roosevelt was seen as the man of the age with his Rough Riders, strong talk, explorations, and hunting expeditions, it was Edith who ran the home and him. She apparently, had mastered "the Look" which brought to heel all renegades in her immediate space. This included the POTUS.

Edith had served as a volunteer nurse for returning troops of the Spanish American War. As First Lady, she continued to give to hospitals and to soldiers especially to former members of the Rough Riders. She would continue this charity through out her life. In 1912, her skills were again used as she nursed her husband from a bullet wound he received during an attempted assassination attempt while attending a Chicago rally.

She was fickle and harsh with her friendships. Her brother-in-law, Elliot, Theodore's younger brother, was an alcoholic. He had a love child by a house maid. Edith forbade Alice and her children from having anything to do with his legitimate children, Eleanor and Elliot, Jr. This rift lasted through the cousins' lives. There were also tensions between Edith and her step-daughter mainly because of Edith's feelings concerning her husband's deceased first wife.

Edith hosted Alice's White House wedding to Congressman Nicholas Longworth in 1908 with a thousand invited guests. She also extended to Eleanor the use of the mansion for her wedding to a distant cousin, Franklin Delano Roosevelt. The couple declined her offer. Edith found FDR to be loud. Later, when he ran for President as a Democrat, she and Alice continued their very visible support of the Republican candidate. Similarly, she estranged herself from her sisters-in-law with whom she had been friends since childhood. The reason remained unknown. It was just Edith's way.

The Roosevelts left the White House in 1908. The former president sought a commission in the Army during WWI but was denied because of his age. Their three sons served. Ted, Jr., was gassed and shot and Archibald was also wounded. Sadly, Quentin, 21, a pilot, was shot down and killed in 1918. Six months later, President Roosevelt died from a heart attack. He was 61. Edith did not attend the public funeral. A few days later, she and Kermit left for Europe to visit Quentin's grave.

As a widow, Edith spent a great deal of time traveling around the globe. Never a suffragette, she did support the law which gave women the vote once it was enacted. When Prohibition was made law, Edith did an about face. Never one for drink, she now was busily serving cocktails to guests in her homes. She felt that it was up to the individual to make this choice to drink or not to drink and the government should not impose its will on the people.

In 1943, while serving in the Army in Alaska, Kermit killed himself. Kermit suffered from alcoholism. Edith was told he had died of a heart attack. He was 54. On June 6, 1944, Ted, 57, did die of a heart attack during the Normandy Invasion. It was he who led the attack on Utah Beach. He was posthumously awarded the Medal of Honor. In April of 1945, FDR died. Ethel Roosevelt Derby died in 1977 and Archibald, who suffered additional wounds in WWII, in 1979. Alice Roosevelt Longworth died in 1980 at 96.

Edith died at age 87 in 1948 at her home on Montauk, Long Island. She is buried in Young's Cemetery at Oyster Bay next to her husband, the 26th President.

Is that the best they can do?

Honestly, I don't even care if the Russians did get them. That's not the point. The point is, what is in those emails that show us that Hillary Clinton and President Obama committed crimes and could be convicted of treason, if the system wasn't so corrupt? KAINE...ANTI-ISRAEL AND SO MUCH MORE!

If you go online to fact check the following article, you will find many sites that will tell you that what I am writing is not true. These are liberal sites. On the other hand, you will find other sites that I personally find reputable that say these things are true. Now that I have done my disclaimer...you decide what you want to believe.

Tim Kaine, Hillary Clinton's vice presidential pick, is tied into some very dangerous anti-Israel people. Tim Kaine has a history of embracing radical Islamists. In fact, Tim Kaine is one of the top anti-Israel senators in Washington, and he receives PAC (Political Action Committee) funds from George Soros's anti-Israel group called J Street. Omeish later denied that he had advocated violence saying, "In Islam, jihad is a broad word that means constant struggle — struggling spiritually, emotionally, intellectually, physically — in all respects. So my words were in support of people who are resisting occupation and people who are trying to . . . remove oppression from their land." I'm sorry, but that story is not credible in my mind. Jihad is jihad!

Federal prosecutors said in a 2008 court filing that the Muslim American Society (MAS) was "founded as an open arm of the Muslim Brotherhood in America." The Chicago Tribune also did an investigation in 2004 and concluded that the MAS used semantics to give the impression that they were moderate. Perhaps that explains Omeish's definition of jihad above. That was semantics at its best.

Abdurrahman Alamoudi who was a convicted terrorist and Muslim Brotherhood member stated in 2012 that "Everyone knows that MAS is the Muslim Brotherhood." When a state delegate wrote Governor Kaine warning him that the MAS had "questionable origins," he was accused of being bigoted.

Kaine also has close ties with Jamal Barzinji, whom the Global Muslim Brotherhood Watch describes as a founding father of the U.S. Muslim Brotherhood. Barzinji is a major Brotherhood player in the U.S. and was vice president of the International Institute of Islamic Thought (IIIT), which was put under investigation for terrorist ties. An informant inside the Brotherhood identified Barzinji and his associated groups as being part of a network of Brotherhood that was put here to start an Islamic Revolution in the United States. The source said Barzinji and his colleagues were organizing political support which involved influencing public opinion in the United States by using political action front groups with no traceable ties. Barzinji was on the brink of being prosecuted, when the Obama Justice Department stopped the indictment.

The jihadist's strategy in the United States is to seek to obtain support from influential individuals under the pretense of promoting and protecting Arab rights.

One needs to consider a video from an event honoring Barzinji which shows Kaine saying that it was his fourth time at their annual dinner while he thanked the organizers of the event for helping him in his campaign for lieutenant-governor and governor and asked them to help his Senate campaign.

Kaine and Hillary's love affair with jihadists is a quid pro quo. Kaine appoints them to powerful positions, and they give him money. Hillary does the same. Barzinji's New Dominion PAC donated \$43,050 to Kaine's gubernatorial campaign. The PAC also has strong ties to the Democratic Party in Virginia with almost \$257,000 in donations. The Middle East Forum's Islamist Money in Politics database shows another \$4,300 donated to Kaine's Senate campaign in 2011-2012 by officials from U.S. Muslim Brotherhood entities. Another \$3,500 came from Barzinji's IIIT organization. Kaine was one of the few senators who totally backed Obama and Hillary's Middle East disaster, which included open disrespect and hostility toward our ally, Israel.

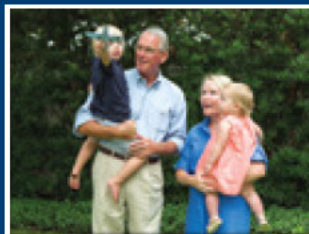
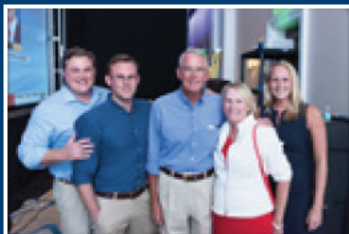
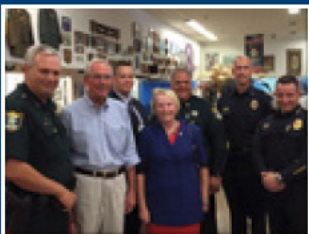
