Legislative UPDATE

A Legislative Snapshot.
A look at Juvenile Justice.

As the schools across the country have opened for the 2016 – 2017 school year, Congress looks into Juvenile Justice. With everything that is occurring across the nation with our young people policy makers are looking at what can be done to change the cycle of behaviors in our schools and on the streets.

The House Education Committee Passed a Bipartisan Bill to Improve Juvenile Justice

The House Education Committee considered the Supporting Youth Opportunity and Preventing Delinquency Act of 2016 (H.R. 5963), and passed it in a nature of a substitute amendment to the Juvenile Justice and Delinquency Prevention Act of 1974 (JJDPA) by unanimous consent.

Since 1974, the Juvenile Justice Committee has coordinated federal resources aimed at improving state juvenile justice systems with a focus on education and rehabilitation. To reauthorize and improve this law, members introduced H.R. 5963, which if passed by Congress, would help state and local leaders better serve at-risk youth and juvenile offenders. The bipartisan bill would strengthen prevention and rehabilitation support by:

- Providing states and local leaders flexibility to deliver services that meet the specific needs of delinquent youth in their communities.
- Promoting opportunities for juvenile offenders to acquire skills necessary to grow into productive members of society.
- Helping at-risk youth avoid the juvenile justice system by supporting prevention services.
- Prioritizing evidence-based strategies with proven track records and long-term solutions for addressing juvenile delinquency.
- Improving accountability and oversight at all levels of the juvenile justice system.

The House Education Committee agreed in a bipartisan manner to pass H.R. 5963 and advance it for consideration on the House floor. Further, the Senate is currently in the process of drafting legislation to reauthorize the juvenile justice law.

In Lee County a collective group of interested individuals including Judge James Seals, Lee County Sheriff, Mike Scott, Superintendent of Schools, Dr. Greg Adkins, and Lee County School District Director of Student Services, Mr. Pete Bohatch came together to look at what could be done and put in place a program called Restorative Justice. Is it working? Read the Legislative article for the month of November to find out.

AMERICANISM Republican First Ladies

Ida Saxton Mc Kinley was a warm, quick witted, forceful daughter of James Saxton and Catherine “Kate” De Walt Saxton. She was born into the Presbyterian family on June 8, 1847, the oldest of three children.

Both her paternal and maternal families were among the founders of Canton, Ohio. They were close, affluent and influential.

Her paternal grandfather and father were abolitionists associated with the Canton underground railroad. Her father, a supporter of women’s rights, desired his daughters to be independent and not look to marriage for financial security.

The Saxton women were very close. During the Civil War, Ida, a teenager, helped her mother and grandmother sew uniforms for the Union soldiers. She then attended finishing school, and did the grand tour of Europe with her sister Mary. In Belgium, she developed a passion for lace having watched the women

continued to collect throughout her life. Upon her return, her father hired her as a cashier and as acting manager for his bank. These were unheard of positions for women. She rose above the ridicule and succeeded giving great pleasure to her father and to herself.

Ida met William Mc Kinley in 1868 thinking, “He could be President some day.” By today’s standards, the McKinley’s would have been seen as a power couple. And power they obtained but they also suffered great loss, but not the loss of their love nor their faith. The disappointments and grief came in rapid succession. First, her beloved grandmother died two weeks before their wedding in 1871. Then, two weeks after the 1873 birth of their second daughter, Little Ida, Kate Saxton died. Four months later, Little Ida died.

That same year, Ida began having seizures and was diagnosed with epilepsy. In 1875, the oldest daughter and surviving child, died at five years of age from scarlet fever. Shortly after, Ida suffered a fall injuring her head and leg leaving her temporarily immobile. The treatment was complete bed rest which resulted in pleurisy.

Ida was a First Lady of Ohio before becoming First Lady of the US. Her sister, Mary, helped and cared for Ida and took over as White House hostess when necessary.

The public knew of Ida’s health problems. At the time, seizures were synonymous with mental illness. Nevertheless, Ida did become a role model for those with physical and mental disabilities. The public was very keen on her husband whose devotion to her was greatly admired. She did participate in White House functions when able. When incapacitated, she knitted thousands of slippers which she gave away or were auctioned by charities. She also financed the education of her African-American wash lady’s children.

In April of 1901, Ida and the President were in California where she developed a life threatening infection forcing her to recuperate in San Francisco. Because of this, the President postponed a planned visit to Buffalo, New York, until September.

On the morning of Sept. 6, 1901, Ida stayed at the hotel to rest. She was not with her husband when he was shot by Leon Czogosz. She was not told of his injuries for at least a day. Simultaneously, the President’s concern was for her imploring those around him after he was shot to tell her gently.

Appearing that he would survive, Ida was brought to him. For a week, he did rally but, unfortunately, he succumbed to gangrene. His last words were, “What shall become of her?”

Following the funeral, Ida oversaw the building of his monument. She visited his coffin daily for 30 months until its completion. She also was very interested in helping the African American, James “Ben” Parker, who tackled the assassin before he could get off a third shot.

She died on May 26, 1907 and is buried next to her husband. Her funeral was attended by President Theodore Roosevelt.
